ON 6/28/17 AT APPROXIMATELY 2235 HOURS, I WAS AT THE ON CUE LOCATED AT NW 23RD AND SANTA FE WHEN I WAS APPROACHED BY AN INDIVIDUAL LATER IDENTIFIED AS VI [REDACTED]. VI STATED TO ME THAT SHE WAS UNSURE WHAT SHE NEEDED TO DO, BUT HAD AN ASSAULT HAPPEN TO HER ON MONDAY NIGHT AND SHE NEEDED TO FILE A POLICE REPORT.

VI STATED SHE DRIVES FOR UBER AND WAS TRANSPORTING A CUSTOMER WHEN HE MADE ADVANCES ON HER DURING TRANSIT. VI PICKED UP SU AT 2159 HOURS AND DROPPED SU OFF AT 2236 HOURS.

VI DESCRIBED SU, [REDACTED] AS GRABBING HER FORCEFULLY AND KISSING VI ON THE NECK WHILE SHE WAS DRIVING. THIS OCCURRED ON THE LAKE HEFNER PARKWAY EN ROUTE TO SU'S DESTINATION AT A HOTEL SOMEWHERE OFF EXPRESSWAY. AFTER ARRIVING AT THE HOTEL, SU HAD VI DRIVE TO THE PUMP BAR LOCATED AT NW 24TH AND WALKER. VI WAS ABLE TO OBTAIN BASIC INFORMATION FOR SU AND WAS ABLE TO FIND A PICTURE OF HIM ON THE INTERNET WHICH SHE SHOWED ME.
