ON 10-26-2002 AT APPROX. 0301 I OBSERVED A VEHICLE TRAVELING NORTHBOUND ON 9<sup>TH</sup> APPROACHING OMAHA (51<sup>ST</sup>), THE VEHICLE APPEARED TO BE TRAVELING AT A HIGH RATE OF SPEED, I VISUALLY ESTIMATED THE VEHICLES SPEED BETWEEN 55 AND 58 MPH IN A 40 MPH ZONE, USING THE KUSTOM GOLDEN EAGLE RADAR IN THE STATIONARY MODE I LOCKED ON A SPEED OF 58 MPH. I ACTIVATED MY EMERGENCY LIGHTS AND STOPPED THE VEHICLE AS IT TURNED EAST ON OMAHA FROM 9<sup>TH</sup> ST. I APPROACHED THE VEHICLE AND ASKED THE DRIVER FOR HIS DRIVERS LICENSE AND INSURANCE VERIFICATION. THE DRIVER PRODUCED BOTH FOR THIS OFFICER AND I ADVISED HIM WHY HE WAS BEING STOPPED. THIS OFFICER RAN A DRIVERS LICENSE STATUS AND A WANTED CHECK AND WAS ADVISED THAT THE DRIVERS, DRIVERS LICENSE WAS CURRENTLY UNDER SUSPENSION, FURTHER THAT THE DRIVER HAD TWO OUTSTANDING MISDEMEANOR WARRANTS THROUGH THE CITY OF BROKEN ARROW. THE DRIVER WAS PLACED UNDER ARREST AND TRANSPORTED TO THE BROKEN ARROW CITY JAIL FOR BOOKING. THE VEHICLE WAS RELEASED TO THE DRIVERS WIFE.
