REASON FOR CONTACT:

On 08/02/2019, I was dispatched to the area of 4800 South Aspen Avenue, in the City of Broken Arrow, in Tulsa County, for a report of a drunk driver. The Broken Arrow Communications Division told me the reporting party stated the driver was straddling the lanes of the road and going left of center.

INFORMATION: Sgt. J. McCoy notified Communications he was in the area on the radio when the call was put out. Sgt. McCoy stated he located the vehicle south bound on Aspen at the Creek Turnpike. Sgt. McCoy conducted a traffic stop in the area of 7900 South Aspen Avenue, in the City of Broken Arrow. When I arrived, Sgt. McCoy told me he stopped the drivers for driving left of the center line and Speeding (54 mph in a posted 40 mph zone). Before I approached the vehicle, Sgt. McCoy told me he could smell a strong odor of alcohol coming from the driver's breath or person.

CONTACT WITH DRIVER: When I approached the vehicle, I asked the driver, identified as Dean Davis (04/29/1972), where he was coming from. Davis stated "a friend's house." I asked Davis if he had been drinking alcohol this evening. Davis replied "Yes, I've had a couple." While speaking with Davis, I noticed he had blood shot watery eyes and slurred his words while speaking. I also could smell the odor of alcohol coming from Davis's breath or person. I asked Mr. Davis to exit the vehicle and submit to a field sobriety test to determine if he was safe to drive. Davis looked up at me and stated "Do I have to call your police chief?" Davis exited the vehicle and braced himself on the door as he was exiting.

SFST TESTS:

HGN: During the test I observed a lack of smooth pursuit in each eye, distinct and sustained nystagmus at maximum deviation in each eye, and Davis had onset of nystagmus prior to 45 degrees in each eye. During the test, the stimulus was held approximately twelve to fifteen inches from Davis's eyes. 6 of 6 clues were observed during HGN.

WALK AND TURN: During the test, Davis was told twice to maintain the instructional position. Davis took 10 steps and did not touch heel to toe and had to raise his arms for balance. Davis also placed a hand on his vehicle while walking next to it to maintain his balance. 4 of 8 clues were observed.

ONE LEG STAND: During the one leg stand, Davis place his foot down, swayed while balancing, and used his arms for balance. 3 of 4 clues observed.

Davis was placed under arrest for suspicion of driving under the influence of alcohol. When I told Davis to place his hands behind his back, he refused and stated "I think you need to call your Police Chief."

Davis continued to resist arrest and was placed against his vehicle while Sgt. McCoy and I placed him in restraints.

Davis was transported to the Broken Arrow City Jail where he was read implied consent from the printed copy. Davis

again stated, "You need to call your Police Chief." I asked Davis three times if he would take the States Test (breath) to which he answered, "I want the blood test". I informed Davis he would be required to take the breath test, prior to any other testing and asked Davis again to take the states test. Davis replied, "You have to give me the blood test."								
I explained to Davis the test would be subm	nitted as a refusal.							
Davis will be transported to the Tulsa Count	ty jail at a later date.
