COUNT 7: CRIMES AGAINST NATURE BY BEASTIALITY ~ 21 O.S. § 886, a FELONY

STATE OF OKLAHOMA, COUNTY OF HUGHES:

I, Paul B. Smith, the undersigned District Attorney of said County, in the name and by the authority of the State of Oklahoma, give information that in said County of Hughes and in the State of Oklahoma, JAMES HENRY JACKSON did then and there unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

CONSPIRACY ~ a FELONY, on or between the 20th day of March, 2017 and the 15th day of February, 2020, by conspiring and agreeing with Rebecca Jackson and Autumn Jackson to commit the crimes of Possession of Child Pornography and violating the Computer Crimes Act, a felony, by agreeing with Autumn Jackson and Rebecca Jackson to possess, remove, and seclude child pornography to violate the Oklahoma Computer Crime Act and said defendant and Rebecca Jackson and Autumn Jackson did in furtherance of the conspiracy to possess, remove, and seclude child pornography did travel to 3550 South Sheridan in Tulsa Oklahoma and rent a storage unit to store, house, and seclude the said child pornography on computer hard drives and flash/thumb drives.

This crime is punishable by imprisonment for up to 10 years, or a fine of up to \$5,000, or both.

LEWD OR INDECENT ACTS TO CHILD UNDER 16 ~ a FELONY, on or between the 20th day of March, 2017 and the 15th day of February, 2020, by knowingly and intentionally looking upon the private parts of Baby Doe in a lewd or lascivious manner by act(s) against public decency and morality by spreading the legs of a nine-month old female Baby Doe and by looking upon, touching, feeling, Baby Doe, when Baby Doe was 9 months old and James Henry Jackson was 56 years old.

This crime is punishable by imprisonment in the custody of the Department of Corrections for not less than twenty-five (25) years.

LEWD OR INDECENT ACTS TO CHILD UNDER 16 ~ a FELONY, on or between the 20th day of March, 2017 and the 15th day of February, 2020, by knowingly and intentionally enticing and persuading Toddler Doe to go alone with Henry Jackson to a secret and remote place in a lewd or lascivious manner by act(s) against public decency and morality by persuading two-year-old Toddler Doe to go alone with Henry Jackson to a secret and remote place, when Toddler Doe was 2 years old and James Henry Jackson was 56 vears old.

This crime is punishable by imprisonment in the custody of the Department of Corrections for not less than twenty-five (25) years.

COUNT 4: VIOLATION OF OK STATUTE VIA COMPUTER ~ a FELONY, on or between the 1st day of March, 2018 and the 15th day of February, 2020, did unlawfully store data in computer systems, networks, hard drives, flash/thumb drives, and other electronic media devices for the purpose of using such access to a computer to violate Oklahoma law relating to maintaining child pornography, obscenity, bestiality, and crimes against nature.

This crime is punishable by imprisonment for not more than 5 years or by a fine of not more than \$5,000, or by both such imprisonment and fine.

COUNT 5: INDECENT EXPOSURE by PROXY ~ a FELONY, on or between the 1st day of March, 2018 and the 15th day of February, 2020, by willfully, knowingly, and lewdly encouraging and directing Autumn Jackson to remove her clothing and expose herself indecently to minor children at 120 South Main, Wetumka, Oklahoma.

This crime is punishable by imprisonment up to 10 years or a fine up to \$20,000, or both.

COUNT 6: AGGRAVATED POSSESSION OF CHILD PORNOGRAPHY ~ a FELONY, on or between the 1st day of March, 2018 and the 15th day of February, 2020, by possessing, with knowledge of its contents, one hundred (100) or more separate materials depicting child pornography, to wit by possession approximately one-hundred and twenty (120) images of consisting of child pornography, one (1) video depicting child pornography, and four (4) Microsoft Word documents containing child pornography.

This crime is punishable by imprisonment for not more than life and by a fine of not more than \$10,000.00. A person convicted of this crime shall be required to register as a sex offender pursuant to the Sex Offenders Registration Act.

COUNT 7: CRIME AGAINST NATURE BY BEASTIALITY ~ a FELONY, on or between the 1st day of March, 2018 and the 15th day of February, 2020, by committing the detestable and abominable crime against nature by having unnatural and carnal copulation by the mouth of a dog/beast of nature and also performing a manual sex act on the dog/beast..

This crime is punishable by imprisonment for up to 10 years.
