

REQUEST FOR ETHICAL INQUIRY

SWORN STATEMENT OF LAURA BETH PERRY

I, Laura Beth Perry, declare under the penalty of perjury, pursuant to 28 USC sec 1746 as follows:

1. I am over 18. I am a private citizen.
2. I am a resident of Oklahoma and am registered to vote in Oklahoma.
3. I met Chris Sevier Esq. for the first time on February 2, 2021.
4. I spent the day with him at the Capitol to advocate for several different bills that advance pro-family Judeo Christian values.
5. We met with countless offices to discuss the merits of different pieces of legislation that Mr. Sevier and I think would promote human flourishing and advance the rule of law.
6. On February, 24, 2021, when Mr. Phillips admitted to Tres Savage at NonDoc.com that another woman was in the room, I was the other woman.
7. Around 1:30pm while waiting for a meeting with the House Majority Leader Echols regarding a meeting that was scheduled the day before, I got into a conversation with Logan Phillips' legal assistant because I had attended her church a few times and we had some mutual friends. Mr. Sevier and I then asked if we could meet with Mr. Phillips for just a minute to discuss some proposed legislation, as we had been doing with other legislatures throughout the day. It is my observation that Mr. Phillips was acting irrational and bizarre. After attempting to explain one of several bills to Mr. Phillips, Phillips was getting more and more agitated. Mr. Sevier said something to the effect of, "Why don't you support the Life-Appropriation bill then if you claim to be a Republican." Mr. Phillips jumped out of his chair and accused Mr. Sevier of threatening him. Mr. Sevier and I quickly left while Mr. Phillips followed us out into the reception area where he instructed his assistant in angry tone, pointing at us.

He then proceeded into the hallway to follow Mr. Sevier and ask his name. Mr. Sevier was on a phone call by that point and could not answer right away. Phillips, a much bigger, taller man than me, stood over me and demanded to know Mr. Sevier's name. I, myself being new to these types of proceedings, was not sure what to do and froze. I did not say anything in response. Mr. Phillips walked down the hall towards Mr. Sevier, yelling in a loud voice, demanding to know his name, and asking security to remove Mr. Sevier. He also swore that Mr. Sevier would not be able to get a hearing with House Majority Leader Echols as long as he (Phillips) were in the house.

I found Mr. Phillips' actions to be intimidating and unprofessional in his conduct. In the hallway, Mr. Phillips was demonstrating hostile intent to ensure no one else would hear Mr. Sevier's

proposed legislation. It was contrived. I observed Mr. Phillips knocking repeatedly on Leader Echols door. Mr. Phillips was shouting that Mr. Sevier had threatened him and Mr. Sevier did say to Mr. Phillips that his assertion was false and defamatory. Very obviously Mr. Phillips was trying to cause a scene for self-serving reasons in a manner that was objectively unethical and an abuse of his office.

8. Mr. Phillip's statement to the press that there was a "physical altercation" was patently false. Mr. Sevier made no threats nor did anything inappropriate whatsoever. There was no physical contact whatsoever, in the office or in the hallway.


9. On February 24, 2021, Mr. Phillips told Tres Savage at NonDoc.com that Mr. Sevier "then jumped up, started telling me how I was a pedophile and how awful I am in no uncertain terms and that there's nothing he needed to be in my office for anymore" was a statement that is patently false." Mr. Sevier never called Mr. Phillips a pedophile or indicated anything of that sort.

10. It is my observation and opinion that Mr. Phillips published a false report to the Capitol police.

11. Based on my direct interaction with Mr. Sevier at the Capitol, Mr. Phillips intentionally and maliciously set out to cast Mr. Sevier in a false light. His actions were defamatory. If Mr. Phillips does not like the legislative proposals advocated by another, he is entitled to vote no and to oppose the measures. But the self-help measures he undertook were categorically unlawful and unethical.

12. I ask that these matters be investigated and that if found guilty that adverse action be taken against Mr. Phillips to deter such practices in the future to maintain the public's trust and confidence in the Oklahoma legislative branch.

13. I was in many other meetings with Mr. Sevier on the day of February 2, 2021, and there were no other problems with any of the other Senators or Representatives that day.
