INDICTMENT

IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OKLAHOMA:

By the order of the Supreme Court of Oklahoma, the Nineteenth Multicounty Grand Jury was convened with its principal site to be in Oklahoma City, Oklahoma County, Oklahoma, to serve from January 20, 2022, for eighteen (18) months, or until the designated presiding judge determines the Nineteenth Multicounty Grand Jury has reached reasonable completion of its investigations, but, in any event, no more than twenty-four (24) months from the commencement of its term. That said Multicounty Grand Jury of the State of Oklahoma, being composed of good and lawful men and woman, legally drawn and summoned according to law, and then and there examined, impaneled, sworn, and charged according to law to diligently inquire into, and true presentment make, of all public offenses against the State of Oklahoma committed and triable within the State of Oklahoma, upon their oath, and in the name and by the authority of the State of Oklahoma, do present and find:

COUNT 1: EMBEZZLEMENT, 21 O.S. §1451

On or between June 2012 through December 2021 the crime of EMBEZZLEMENT was feloniously committed in Custer County and multiple other counties within the State of Oklahoma, by JOE DON DICKEY, who willfully, feloniously, and fraudulently, without authorization,

appropriated money in excess of \$2,000,000 (two million dollars) from Circuit Engineering District 7 and the State of Oklahoma, when said money was legally obtained, and entrusted to the defendant for a specific purpose, use, or disposition and/or was to be used for a public or benevolent purpose, by diverting funds to another entity for purposes not intended or authorized contrary to the provisions of Section 1451 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.

COUNT 2: CONSPIRACY, 21 O.S. §421

On or between June 2012 through December 2021 the crime of **CONSPIRACY** was feloniously committed in Custer County and multiple other counties within the State of Oklahoma, by **JOE DON DICKEY**, who willfully, feloniously, conspired with Monte Goucher, Jerry Dean, and Tim Bingham, to embezzle State funds and said Jerry Lynn Dean, Joe Don Dickey, Monte Goucher and Tim Bingham did orchestrate the management, construction, and operation of 7 OIL Joint Venture with Circuit Engineering District 7 contrary to the provisions of Section 421 of Title 21 of the Oklahoma Statutes and against the peace and dignity of the State of Oklahoma.



**ORDER DETERMINING VENUE, REQUIRING TRANSMITTAL OF INDICTMENT
TO COUNTY OF VENUE, AND AUTHORIZING DISTRICT COURT TO OPEN FOR
PURPOSE OF ISSUANCE OF WARRANT**

NOW on this 3 day of March, 2022, the Court having been present, in open court, an indictment returned by the Oklahoma Multicounty Grand Jury, the Court finds and orders as follows:

1. Said indictment having been examined by the Court, the Court pursuant to the provisions of 22 O.S. Section 358, finds and orders that venue and jurisdiction shall be in Custer County, State of Oklahoma.
2. That said indictment shall be transmitted by the Attorney General, or one of his Assistant Attorneys General, to the District Court Clerk of Custer County, who, thereafter, upon receipt shall notify the District Judge of Custer County of the filing of the same;
3. That the District Judge of Custer County shall proceed according to the provisions of Title 22 O.S. Section 386.
