Press Report

On November 20, 2019 at or around 1450hrs, Vice President of Administration and Finance for East Central University (ECU) Jessica Kilby asked that I come to her office 163 Administration building here at ECU to sit in with suspended Bursar Brian Hampton. Mr. Hampton was coming in voluntarily to bring property belonging to ECU and discuss what has been going on. At or around 1515hrs Mr. Hampton arrived and was greeted into VP Kilby's office 163 ECU Administration, with VP Jessica Kilby, HR Director Ty Anderson, Officer Jones, Chief Miller, and Frank Crawford (speakerphone) present. At first Mr. Hampton handed over a computer bag that contained a combination of over One Hundred Fifty Thousand 150,000 dollars in checks and cash that belonged to ECU he explained he had several things going on and couldn't remember a lot. Mr. Anderson, Ms. Kilby, and Mr Crawford asked a lot of questions specifically about things they had discovered in the records that didn't add up. After a short break for Mr. Hampton to clear his head and settle down, with everyone out of the room except Mr. Hampton, Officer Jones and Chief Miller. Mr. Hampton told me that he had a female friend that was in need, so he used some cash to help her out and hadn't been able to replace it. Shortly after, everyone else came back into the room and he told the same explanation to them as well. It was learned from Mr. Hampton that this situation had started in early August when he took a couple thousand dollars with the intention of paying it back but never did, he also spoke of taking game ticket cash and moving it around to cover other deposits. He advised that during the time he was moving money around he accidentally took deposits which included checks and cash and either the cash totaling around ten thousand 10,000 was stolen or lost he didn't know where it was, so he started taking out loans to pay it back with his own personal funds. Mr. Hampton took total responsibility for his actions and stated that he was a sole actor in this matter.
