NARRATIVE No: 1 - Officer: ARD HAGAN

On October 15th, 2022 at approximately 2250 hours, officers were dispatched to the lobby of the Clinton Police Department in reference to someone making a fake Facebook account.

Upon arrival, I met with Ashley Kelley (Teacher at Clinton Public Schools), who stated that on 10/11/2022 she woke up to messages on her phone regarding a post that was made on her Facebook account. Ashley then showed me the message that was posted on her account and stated that she was not the one who made the post. Ashley then proceeded to show me emails from her school email as well as Facebook messages that were from people expressing their opinions regarding the post that was made on her Facebook account. Ashley believes that the people who were sending her emails got her email from the schools website. Ashley stated that she is meeting with the School Admins on 10/16/2022 to discuss the incident.
