NARRATIVE No: 1 - Officer: CASINGER, TRENT

On August 16th at around 1945 hours I, Officer Trent Casinger, was dispatched to 1130 Robin Hood Rd for possible drugs that were found at the residence. When I arrived I was met by Stephanie Winesburg who stated that while cleaning her mother's room she found what she believed to be a baggie of cocaine on a book shelf located in the master bedroom. The baggie was behind a family picture and contained a white powdery substance. Winesburg advised that she believed it to belong to the boyfriend of her late mother, Dan Kirby. Winesburg stated that Kirby had been staying at the house for two years and slept on the right side of the bed which is where the shelf was located. I then took photos of where the baggie was found before taking possession of it and a straw that was found in the same location. Once back at the Police Dept I tested the white powdery substance and it indicated positive for cocaine. I logged the evidence and then returned to normal duties.
