COUNT 1: COMPUTER FRAUD / UNLAWFUL USE OF COMPUTER / SYSTEM ~ a FELONY, on or between the 2nd day of June, 2021 and the 4th day of June, 2022, by using a computer device willfully and without authorization to make use of date belonging to

This crime is punishable by imprisonment of 10 years and/or \$5000 to \$10,000 fine.

NONCONSENSUAL DISSEMINATION OF PRIVATE SEXUAL IMAGES ~ a FELONY, on or between the 2nd day of June, 2021 and the 4th day of June, 2022, by disseminating, without consent, private sexual images with the intent to gain anything of value to wit by disseminating nude images of intent to gain nude photos of other women and children.

This crime is punishable by imprisonment of up to 4 years.

COUNT 3: SHOWING OBSCENE MATERIAL TO MINOR ~ a FELONY, on or between the 2nd day of June, 2<u>021</u> and the 4^{sh} day of June, 2022, by showing a minor child, the intent of getting to distribute obscene material.

This crime is punishable by imprisonment of 10-30 years.

retrieved the login history and account information for her Snapchat account. 1 discovered that beginning on June 6, 2021, an unknown device was accessing her account. The device model number was SM-N975U. (NOTE: Your affiant knows that model number to be associated with Samsung cellular devices.) Snapchat provided dates, times, device, and IP addresses associated with each login.

On June 14, 2022, STEWART contacted Oklahoma State Bureau of Investigation Lieutenant JOSH DEAN and requested assistance with the investigation. DEAN reviewed the records STEWART had received from DEAN checked the IP addressed associated with the logins from the Samsung device. DEAN located IP address that was used for the logins that was maintained by Cable One Inc. a/k/a Sparklight. A summons was served to Cable One requesting subscriber information related to the IP address.

DEAN learned from STEWART that MILLIREN was currently employed by the Byng Public Schools in their IT department.
On June 21, 2022, DEAN and STEWART interviewed stated she used the same passcode or a variation thereof for her Snapchat account as she did for her Byng school's computer login. In the Mark MILLIREN, but rarely spoke with him, was never friends with him on any social media platform, never gave him access to any of her accounts, and never gave him her passwords.
STEWART counted the number logins to account by MILIREN between July 6, 2021, and June 4, 2022, it was over eight-hundred (800) times.
On June 22, 2022, DEAN and STEWART interviewed MILLIREN. MILLIREN had worked for the Byng Public School since November 20, 2015. MILLIREN provided the following personal information: address: Ada, Pontotoc County, Ada, Pontotoc County, Phone Innumber: Email address: Knew MILLIREN and had been in her classroom on a couple occasion to install computer related equipment. MILLIREN was not friends with on social media and rarely used any social media platforms except for Tiktok. MILLIREN did have a Snapchat account, his username was zacm666. MILLIREN stated he was the only user of his cell phone, he only used his cell phone to access social media, and he did not use any of the school's devices to access any social media. MILLIREN stated he had additional devices at his house to include a computer and Apple iPad.
At the conclusion of the interview, DEAN took possession of MILLIREN'S cellular devices. MILLIREN had two cell phones in his front pocket. Those devices were a black/silver Samsung model SM-N975U cell phone and a black/blue Samsung model SM-N960U cell phone. The SM-N975U was the same type of device listed as accessing account.
On June 23, 2022, STEWART interviewed a juvenile Byng student, confirmed he had recently accepted an unknown friend request through Snapchat. The unknown user provided with a list of individuals of whom he had nude photographs of and sent images of the unknown user requested to send them nude photos of other local students and staff in trade.
On June 24, 2022, Agents executed a search warrant at MILIREN'S residence located at Pontotoc County, Oklahoma. Agents verified MILLIREN'S IP address associated with his house was the Agents also

discovered computer related equipment that could have potentially allowed MILLIREN to intercept network traffic.
