## Narrative Information

On 3-23-23 at approximately 2:11 myself and Lt. Cooper were traveling East on E. Main going to the station for the end of shift. We observed several people on the patio of the bar Skinny Slims located at 201 E Main. This is a violation for a bar to allow people to still be drinking on the patio after 02:00. Lt. Cooper and I walked up to the patio and gave a lawful command for the patrons to leave. There were three males whom were still drinking and did not comply with the first request. The person later identified as AR Davis became argumentative. AR was asked two more times to put his drink down and to leave or he could go to jail. I activated my BWC. AR Davis then put his drink down and pulled out his wallet. AR tried to show us a credential and stated to the effect of you don't know how bad you messed up you will find out tomorrow. At this time I advised AR to put his hands behind his back. AR kept telling [REDACTED] "are you getting this"? [REDACTED] and another subject whom walked away and were now standing on the sidewalk. I walked AR to the patrol car he complained of his shoulder hurting I added a second pair of handcuffs to give him more mobility and double locked the handcuffs.

Once at my patrol car AR stated for me to read his card. I read his OK. House of Representative's card. I then took the card inside to Lt. Cooper. The watch commander was going to come to the scene however was unable to due to a ongoing situation. The decision was made for me to proceed with the arrest and transport AR Davis to the OCD. AR demanded that I call the FOP and superiors. I advised him that Lt. Cooper is my supervisor and the Watch commander is his superior. AR Davis had red watery eyes and slurred speech.

Lt Cooper spoke with WI who advised that at least two of the individuals were State reps and she told them to leave the bar, it was closed several times as well. WI advised that they were told they could not be on the patio drinking. WI advised them that they have to leave however the group kept saying they were representative's. For more information see Lt. Cooper's supplemental report.

I transported AR to the OCD. AR Davis kept saying things to the effect of he feels sorry for me and that we will see how this turns out. AR Davis was medically cleared and booked into the OCD without incident. BWC and Patrol camera available.
