BWC VIDEO AVAILABLE

On 4-9-23 at around 1705 hours, I was dispatched to [REDACTED] Florence Ave in reference to an agency assist. The call notes stated that Mcloud police department arrested a male later known as SU-Grino, Ellie for dui in their city. The call notes stated SU had fighting spurs inside the vehicle along with wooden transport boxes for roosters and thought SU was using them for chicken/rooster fights. SU told the deputies he had roosters used for fighting. Mcloud deputy Corporal Milam was calling in to request an officer to go by [REDACTED] Florence Ave to check on if there was cock fighting going on at the residence. This residence is where SU lived. Msgt. Lambert #1315 arrived on scene and contacted Animal Welfare due to there being a large number of roosters in the back of the property tied to stakes. SU's wife IP-Yee Crespo, Jannine and her three children were at the home during this time.

Upon arrival, Msgt Lambert and Corporal Milam were on scene parked on the street in front of [REDACTED] Florence Ave. Animal welfare investigator J. Summerfield arrived on scene and started conducting her investigation. Lt. Eikel #1837 was contacted and arrived on scene. Lt. Eikel contacted investigations and advised them of the incident. Myself and Officer Fickenscher #2370 were asked to stay on scene to make sure the roosters were not taken off the property until a search warrant could be served in the morning. We stayed parked on the street off the property but could still see the back where the roosters were kept. For more information see officer supplemental reports.
