

Count 58: On or about April 9, 2023, in Oklahoma County, State of Oklahoma and within the jurisdiction of this Court, ELLIE PENNIT GRINO, did commit the crime of Cruelty To Animals, a Felony, by unlawfully and willfully, maliciously deprived necessary shelter to a certain animal to-wit: a rooster in subjugation and the property of Ellie Pennit Grino by then and there not providing shelter, contrary to the provisions of 21 O.S. 1685 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.

Count 59: On or about April 9, 2023, in Oklahoma County, State of Oklahoma and within the jurisdiction of this Court, ELLIE PENNIT GRINO, did commit the crime of Cruelty To Animals, a Felony, by unlawfully and willfully, maliciously deprived necessary shelter to a certain animal to-wit: a rooster in subjugation and the property of Ellie Pennit Grino by then and there not providing shelter, contrary to the provisions of 21 O.S. 1685 of the Oklahoma statutes, and against the peace and dignity of the State of Oklahoma.
