We have reviewed your recently amended application for an initial license, and modified request for consideration of 22 beds. Thank you for supplying facility architectural and structural renderings submitted on July 21, 2023 and updated on August 1, 2023, which identified the 22 beds. OSDH has now been able to complete its appropriate review pursuant to current rules and applicable standards.

As a result of that review, OSDH has identified the following items that will require supplementary follow-up:

1. Infection control plan for patient rooms which contain toilet facilities without a handwash sink.

Please provide us a copy of the required infection control plan within ten (10) days of receipt of this letter and the enclosed hospital operation license.

Please be advised that issuance of a state hospital operation license does not immediately guarantee certification by or complete enrollment with the Centers for Medicare and Medicaid Services ("CMS"). OSDH has repeatedly advised various representatives for the Clinton Regional Hospital ("CRH"), and will continue to advise, that CRH is required to meet all applicable CMS regulations for certification.

Enclosed please find your facility's new license for the upcoming year. The license should be posted at the address of the facility in a conspicuous place, observable by the public. Remember to keep this office informed of any changes in operation or services that may affect the license. Notification of all changes must be in writing.
