ROUT TO SEX CRIMES.

ON 12-17-23 AT APPRX. 0016 HOURS, RECEIVED A CALL TO [REDACTED] ST IN REFERENCE TO THE "OKLAHOMA PREDATOR PREVENTION GROUP" LOCATED A SUBJECT THEY SAY WAS TALKING TO WHO THE SUBJECT BELIEVED TO BE A 15 YEAR OLD BOY.

UPON ARRIVAL, I OBSERVED SEVERAL SUBJECTS INSIDE THE DOORWAY OF THE ADDRESS SPEAKING AND RECORDING AN ASIAN MALE AND AN ASIAN FEMALE. RP [REDACTED] ADVISED THE ASIAN MALE, IDENTIFIED AS SU [REDACTED] HAS BEEN CORRESPONDING WITH HIM SINCE OCTOBER 1 2023 VIA TEXT MESSAGES. RP ADVISED SU BELIEVED RP WAS A 15 YEAR OLD BOY AND WAS GROOMING HIM. RP ADVISED SU HAD EVEN ATTEMPTED TO MEET UP WITH THE 15 YEAR OLD BOY AT TARGET IN MIDWEST CITY, HOWEVER THE SU DID NOT ARRIVE. RP SAID THAT THE SU HAD ASKED

THE 15 YEAR OLD BOY FOR A PHOTO OF HIM. RP SAID HE HAD TOLD SU THAT HE WAS NAKED AND GETTING INTO THE SHOWER. RP SAID SU THEN SAID "EVEN BETTER." RP ADVISED HE FOUND SU'S ADDRESS AND CAME HERE TO MAKE CONTACT WITH HIM. RP HAD EXTENSIVE DOCUMENTATION OF THE MESSAGES.

I OBSERVED THE INITIAL MESSAGES WHERE SU WAS PRETENDING TO BE A 28 YEAR OLD FEMALE AND EVEN SENT PHOTOS OF AN ASIAN FEMALE. THE MESSAGES STATED FOR REAL THOUGH HOW OLD AND ASKED YOU'RE OKAY AND SAID THAT HE WAS 15 AND SU CONTINUED TO CORRESPOND WITH RP UNTIL TODAY. I EVEN OBSERVED SU TO HAVE SENT RP PHOTOS OF HIS FACE TO RP WHO HE BELIEVED WAS 15 YEARS OLD.

WHILE STANDING WITH SU AND RP SU ADMITTED TO TALKING WITH THE BOY, STILL NOT KNOWING THAT RP WAS WHO HE WAS TALKING TO.

LT KIRBY 1531 WAS CONTACTED AND ARRIVED ON SCENE. SU WAS ASKED IF HE WOULD LET US BOOK IN HIS CELL PHONE AND HE RETRIEVED THE CELL PHONE. WHEN SU OPENED THE PHONE THE INITIAL ITEM THAT POPPED UP WAS A DISCORD CONVERSATION WITH PHOTOS OF A YOUNG MALE, UNKNOWN IF THE MALE WAS A TEEN OR IN HIS EARLY TWENTIES, SODEMIZING ANOTHER MALE. SU GAVE ME THE PASSWORD TO HIS CELL PHONE WHICH WAS [REDACTED] THE CELL PHONE WAS PLACED IN AIR PLANE MODE AND TURNED OFF AFER SU MOVED HIS GRUB HUB APP OVER TO HIS MOTHERS PHONE. SU SIGNED A SEARCH WAIVER FOR HIS PHONE AND I GAVE HIM A CITIZENS ASSISTANCE CARD WITH THIS CASE NUMBER.

I SENT RP AN AXON LINK TO UPLOAD VIDEO EVIDENCE AS WELL AS ALL OF THE DOCUMENTATION.

I BOOKED IN THE HARD COPYS OF THE MESSAGES AS WELL AS THE CELL PHONE AND SEARCH WAIVER IN LOCKER #16 IN THE OCPD PROPERTY ROOM.
