Richard,

I have spoken to Steven Carter and Director Spurlock. Pursuant to the previous negotiations, and our conversation this morning, if Joe Kimmons attends the doctor's appointment on Tuesday and it is determined by the doctor that he is currently unable to work due to his condition our understanding is as follows;

1. Mr. Kimmons will be on sick leave until he reaches his requested retirement date, which my understanding is April ____ 2024. (please provide this date to us)
2. The complaint filed with the Commission against the Director by Mr. Kimmons' wife will be withdrawn and there will be no further complaints filed, nor will any information be discussed with or leaked to the press regarding the OSBI, or the Director. In addition, a letter withdrawing the complaint will be submitted to Monica Holata, as secretary to the Commission, which she will disseminate to the Commissioners.
3. If Mr. Kimmons does not obtain a letter from his doctor, due to his medical condition, he must take annual leave until;
 1. He obtains a letter from the doctor and is currently unable to work due to his condition and retires on the date discussed above. or
 2. Exhausts his annual leave and retires.

I am driving back to Antlers. If you all will get the date in April then hopefully we can get this finished on Monday afternoon.
