

COUNT 1:
BRIBERY BY PUBLIC OFFICIAL – IN VIOLATION OF 21 O.S. 382 – a FELONY,

Between the 23rd day of September, 2023 and the 13th day of November, 2023, the Defendant, **Christopher Morris**, while acting as the duly elected Sheriff of Pittsburg County, unlawfully received a bribe from Dillon Ketchum of McAlester Auto Collision, to wit: free hail damage repair on a privately owned Toyota 4 Runner in exchange for his promise to provide future business from the Pittsburg County Sheriff's for future vehicle repair.
