ORDER APPROVING SETTLEMENT

NOW, on this 20<sup>th</sup> day of June 2024, this comes on for consideration before me, the undersigned District Judge, for approval of a settlement and compromise of a claim to the extent required by the Oklahoma Governmental Tort Claims Act, 51 O.S. §151 *et seq.* The settlement was reached by and between the Claimant, Glynn Simmons, Tort Claim Number 2420033290, and the State of Oklahoma.

The Court, having reviewed this Application for Approval of Settlement, finds, and concludes the following:

1. The Claimant, Glynn Simmons, timely filed a Notice of Tort Claim with the Risk Management Department, Division of Capital Assets Management, Office of Management and Enterprise Services, under the provisions of the Oklahoma Governmental Tort Claims Act, 51 O.S. §151 *et seq.*, seeking compensation from the State of Oklahoma for wrongful conviction.
2. The Claimant has met the requirements set forth in 51 O.S. 154 (B) of the Oklahoma Governmental Tort Claims Act.
3. An Agreement between the Claimant and the State of Oklahoma has been reached to settle and compromise the claim and includes payment of compensation in excess of

\$25,000.00, which requires approval of said settlement by this Court pursuant to 51 O.S. §158(A).

4. The settlement and compromise reached between the Claimant and the State of Oklahoma requires payment by the State to the Claimant, in the amount of \$175,000.00.
5. This settlement and compromise is in complete satisfactions of all demands by the Claimant resulting from his claims, without admission of liability, and is in the best interest of the State of Oklahoma.

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED,** by the Court that the settlement and compromise of the Governmental Tort Claim, Claim Number 2420033290 against the State of Oklahoma, pursuant to the terms of the Release of All Claims entered by and between the Parties, shall be and is hereby approved and shall be entered as a judgment of this Court, as provided by law in accordance with 51 O.S. § 158 (A).
