**MISDEMEANOR ORDER DEFERRING IMPOSITION OF JUDGMENT AND SENTENCE**

Now, on this 21<sup>ST</sup>, day of JUNE, 2024, the same being a judicial day of said Court; the defendant, JAMIE AUBREY BELL, having been legally charged with the crime of OWN/POSSESS/KEEP/TRAIN BIRD FOR FIGHTING ~ 21 O.S. § 1692.5, A FELONY and having been duly informed of the nature of the charge, and of HIS plea of NO CONTEST to the crime of OUTRAGING PUBLIC DECENCY ~ 21 O.S. § 22, A MISDEMEANOR and having been advised of HIS rights and the effect of such plea, it appearing to the Court that said defendant is of the age of 52 years; and the defendant having been asked by the Court whether HE has any legal cause to show why judgment and sentence should not be pronounced against HIM, and HIM stating no sufficient cause why judgment and sentence should not be pronounced against the defendant and none appearing to the Court.

It is therefore the decision and Order the Court to defer the imposition of sentence in this case until 06/21/2025, and the defendant is placed on probation during such period to continue during good behavior and while being a good citizen so long as the said defendant shall comply with the following terms and conditions of probation, to wit:

- (1) That said defendant shall refrain from violation of any city, state, or federal law. (2) Defendant shall not consume any form of alcoholic beverage (3) Defendant shall not enter any establishment where beer/alcohol is sold for consumption on the premise (4) Defendant is to pay fine and cost (5) Defendant shall submit for alcohol/drug test upon the request of law officer (6) Defendant shall perform 25 HOURS of Community Service work, pursuant to the schedule as set by Community Service Director, but not later than FIRST 10- DUE BY AUGUST 21, 2024 OR PAY \$250.00 TO A LOCAL 501C3 ORGANIZATION.

**SPECIAL CONDITIONS: \$1,000.00 FINE PLUS COSTS, 6 MONTHS D.A. SUPERVISION, TO PAY FINES AND COSTS OF \$1,512.25 AT THE RATE OF \$100.00 PER MONTH BEGINNING AUGUST 21, 2024.**
