COUNT 1: UNLAWFUL FOR REGISTERED SEX OFFENDER TO RESIDE WITHIN 2,000 FEET OF SCHOOL, PLAYGROUND, PARK, CHILD CARE FACILITY - §174 TITLE 6 SNCOL - 57 O.S. §590, a FELONY

COUNT 2: FALSE OR MISLEADING SEX OFFENDER REGISTRATION INFORMATION - §174 TITLE 6 SNCOL - 57 O.S. §586, a FELONY or in the alternative OBSTRUCTION OF DUTY- § 156 TITLE 6 SNCOL, a MISDEMEANOR

COUNT 3: FAILURE TO REGISTER AS SEX OFFENDER - § 801 TITLE 6C SNCOL, a MISDEMEANOR SEMINOLE NATION OF OKLAHOMA:

I, Timothy D. Brown, the undersigned Prosecuting Attorney, in the name and by the authority of the Seminole Nation of Oklahoma, being duly authorized and sworn, state the following is true and correct to the best of my personal knowledge and belief:

On or about the 31st day of August, 2024, within the territorial jurisdiction of the Seminole Nation of Oklahoma and within the jurisdiction of this Court, **JIMCY MCGIRT**, the Defendant herein, who is an adult Indian male did unlawfully, willfully, knowingly and wrongfully commit the crime(s) of:

(COUNT I) UNLAWFUL FOR REGISTERED SEX OFFENDER TO RESIDE WITHIN 2,000 FEET OF SCHOOL, PLAYGROUND, PARK, CHILD CARE FACILITY by entering the boundaries of the Seminole Nation Reservation and thereon, after being required to register as a sex offender, reside at 35291 EW 1190 Road, Apartment/Lot 101, Rolling Meadows edition, either temporarily or permanently, within a two-thousand-foot radius of any public or private school site, educational institution, property or campsite used by an organization whose primary purpose is working with children, a playground or park that is established, operated or supported in whole or in part by a homeowners' association or a city, town, county, state, federal or tribal government, a licensed child care center or family child care home or park. Defendant was previously convicted of Aggravated Sexual Abuse in Indian Country in the U.S. District Court for the Eastern District of Oklahoma, and sentenced on or about May 3, 2024, in Case Number CR-20-00050-001-JFH. Pursuant to the Defendant's sentencing, Defendant was required to comply with the requirements of all applicable state, federal and/or tribal sex offender registration.

Pursuant to §164 TITLE 6 SNCOL this crime is punishable as a Class II Felony with imprisonment for up to three (3) years, a fine of up to Fifteen Thousand Dollars (\$15,000.00), banishment for a period for up to three (3) years, or any combination of the above fine, banishment and/or imprisonment.

(COUNT II) FALSE OR MISLEADING SEX OFFENDER REGISTRATION INFORMATION by entering the boundaries of the Seminole Nation Reservation and thereon, after being required to register as a sex offender, providing and/or furnishing false or misleading information related to Defendant's compliance with registration as a convicted sex offender, or in the alternative OBSTRUCTION OF DUTY by entering the boundaries of the Seminole Nation Reservation and thereon knowingly obstructing, preventing, and/or interfering with a police officer engaged in the discharge of the officer's official duty when the Defendant provided false or misleading information to Seminole Nation Lighthorse Officers during an investigation of the Defendant's compliance with registration as a convicted sex offender.

Pursuant to §164 TITLE 6 SNCOL, FALSE OR MISLEADING SEX OFFENDER REGISTRATION INFORMATION is punishable as a Class II Felony with imprisonment for up to three (3) years, a fine of up to Fifteen Thousand Dollars (\$15,000.00), banishment for a period for up to three (3) years, or any combination of the above fine, banishment and/or imprisonment, or in the alternative, OBSTRUCTION OF DUTY is punishable as a misdemeanor punishable by imprisonment for up to one (1) year and a fine of up to Five Thousand Dollars (\$5,000.00), or both such fine and imprisonment.

(COUNT III) FAILURE TO REGISTER AS SEX OFFENDER by entering the boundaries of the Seminole Nation Reservation and thereon failing to register as a sex offender with the Seminole Nation Lighthorse, within three (3) business days after residing within the jurisdiction of the Seminole Nation at 35291 EW 1190 Road, Apartment/Lot 101, Rolling Meadows edition, and that said Defendant was previously convicted of Aggravated Sexual Abuse in Indian Country in the U.S. District Court for the Eastern District of Oklahoma, and sentenced on or about May 3, 2024, in Case Number CR-20-00050-001-JFH.

Pursuant to Section 801 of Title 6C Seminole Nation Code of Laws this crime is a **misdemeanor** punishable by imprisonment for up to one (1) year and a fine of up to Five Thousand Dollars (\$5,000.00), or both such fine and imprisonment.

kids said they were serious. M. Smith stated she asked the children what happened at which point they told her a man began asking them questions. M. Smith asked the children what kind of questions to which the children stated he asked if they had snakes or liked snakes before asking the children if they had food at their house. M. Smith in here written statement, stated that he asked if they had "Sofke" in their house at which point told him no. went on to tell M. Smith the man asked where they lived and ignored the question. M. Smith continued in her statement, stating that told her the man told him that he was Reba's grandpa and he lived at Reba's house. M. Smith stated that after being told it was Reba's grandpa she knew it to be Jimcy McGirt. After filling out statements I asked M. Smith which house it would be that the children were talking about at which point she stated that it would be Ew 1190 lot Ew, Seminole, land located within the boundaries of the Seminole Nation Reservation. I then went to Ew 1190 lot to attempt to make contact with McGirt. Upon arriving at the address I knocked on the door at which point Steven McGirt, Seminole Nation Tribal Member, son of Jimcy McGirt answered the door. I asked his name and asked if Jimcy McGirt was at the residence. S. McGirt stated that he was at which point he made a motion into the house and opened the door completely. After the door was opened further another male, later identified as Jimcy McGirt DOB unknown tribal affiliation, appeared in the doorway. I asked if he was Jimcy to which he stated that he was. I then advised Jimcy of the reason for the interaction and asked his whereabouts for the day. Jimcy stated that he doesn't go anywhere near the kids in the neighborhood. I then asked Jimcy how long he had been staying at the residence and if he had made contact with our SORNA Officer to let him know of his presents at the residence. Jimcy then advised that he did not, however he had made contact with his Federal Probation Officer after his vehicle broke down on Sunday 08/25/2024, and that he would only be staying until it was fixed.

I then attempted to contact Christopher Villanueva, Jimcy's Federal Probation Officer, using a number provided to me by Jimcy, however he did not answer on the initial call. I then spoke with Lt. Talamasey who advised that whether or not his Federal Probation Officer had been notified Jimcy was still required to notify the SORNA Officer with the Seminole Nation Lighthorse Police if he was going to be within the Seminole Nation Reservation longer than 3 days and that Officer Jasna had not been notified by Jimcy. After being informed of this I returned to Jimcy and placed him into custody in violation of Title 6C Section 505- Failure to Appear for Registration.

After placing Jimcy into custody he requested he be allowed to get shoes out of the residence prior to heading to the jail. I advised him that an Officer will need to accompany him and he

otherwise as described in the original call, upon reaching a room on the West side of the house Jimcy requested I grab his wallet that was located on a piece of furniture next to the bed side that was being used as a nightstand. Additionally inside the room was multiple document holders that Jimcy, unprovoked, stated contained all his paperwork from his Federal court case. This is something I would consider odd as Jimcy had previously stated that the only reason he had been at the residence for the time he had was due to his car being broken down and it seemed unusual that someone would carry that many documents around on a day to day basis if not planning for an extended stay. The room that Jimcy had been staying in also appeared to contain other items that would indicate that he intended to stay at the residence on a more permanent basis.

Once Jimcy gathered his shoes and wallet he was taken out to my patrol vehicle and placed into the back seat. Prior to placing Jimcy in the back seat I noticed he did not have his cell phone with him, I asked if he would like to take it with him to the jail at which point he stated yes. I returned to the residence and spoke with Jimcy's son who had his phone when I last seen it and expressed Jimcy's wish to take his phone with him. I then took procession of the phone where it was later placed into Jimcy's property at the Seminole County Jail.

agreed. While walking through the house I did not see any form of wheelchair, electric or

Prior to leaving for the jail I received a call from Officer Villanueva. I advised Officer Villanueva of the nature of the call and that Jimcy had been taken into custody. When informed about Jimcy's statement that he had been in contact with Officer Villanueva, Officer Villanueva indicated that he had not had contact with Jimcy in regards to being in the Seminole Nation Reservation and that he should be in another town outside the boundaries of the Seminole Nation Reservation.

Jimcy was transported to the Seminole County Jail without incident and booked in for Title 6C Section 505- Failure to Appear for Registration.
