AGGRAVATED ASSAULT AND BATTERY -- 21 O.S. § 646

I, Detective Christian Hoehner #1972, your Affiant, being first duly sworn, upon oath, depose and say:

I am a Police Officer employed by The City of Oklahoma City's Police Department. I have been employed by the Oklahoma City Police Department for 9+ years. During my tenure, I have been assigned to the Operations Bureau as a Patrol Officer. I am currently assigned as a Detective to the Assaults Unit within the Investigations Bureau.

That the facts known to the Affiant which establish probable cause to believe that a criminal offense was committed, and that the offense was committed by the above-named person, are the following:

On 11/21/24, the School Resource Officer (Oklahoma City Police Officer) at John Marshall Middle School, 2401 NW 115<sup>th</sup> Terr. Oklahoma City, **Oklahoma County**, was notified of an altercation between a student and a teacher causing injury to the student. There was an incident of "play fighting" that occurred during 5<sup>th</sup> hour (Science/Advisory class) where teachers and students were wrestling and playing around. This initial incident was documented under OKCPD Case Number 2024-0085824. A second altercation occurred involving the same teacher and other students in 7<sup>th</sup> hour (Social Studies class). This incident was documented under OKCPD 2024-0085622.

On 11/25/24, I was assigned the follow-up investigation into these incidents. I spoke to the Principal at John Marshall Middle School who advised me defendant Kiera Smith is a teacher at this school. The Principal obtained numerous written statements from students in the classrooms who witnessed the incidents and from other teachers. These were provided to me for review of additional evidence. The Principal confirmed there was video footage of the incidents taken by Students in the classroom. I interviewed the Principal and obtained a statement from her and what she learned about these incidents.

On 11/25/24, I spoke with [redacted] who is the mother and guardian of [redacted] [redacted] provided me a written statement she gave to the school and provided me the story Victim advised her of the events.

Through my investigation conducting interviews, reviewing written statements, and reviewing video footage this is what I learned:

During [REDACTED] 5<sup>th</sup> hour science/advisory class numerous students including [REDACTED] (13-years-old) and [REDACTED] (13-years-old) began to play fight and wrestle two teachers defendant Kiera Smith and [REDACTED] is the mother of [REDACTED] and they began to horse play in the classroom which caused other students to get involved. Most of the students thought this was funny and some videoed. I reviewed the footage and observed defendant Kiera Smith wrestling with students and placing one student in a hold taking him to the ground while another student jumped on her back. This turned into a small dog pile of students and defendant Kiera Smith. [REDACTED] pulled students off including one student [REDACTED]. The "play fighting" ended and the students went to lunch.

During defendant Kiera Smith's 7<sup>th</sup> hour, [REDACTED] informed defendant Kiera Smith their play fight was not over. [REDACTED] and defendant Kiera Smith began to play fight while the rest of the class sat against the wall watching. [REDACTED] was knocked to the ground by defendant Kiera Smith and Victim got up. Victim came towards defendant Kiera Smith and tapped her on the arm. Defendant Kiera Smith turned and grabbed Victim lifting him off the ground and slammed him to the ground. This caused Victim to break his collar bone. Victim was on the ground in pain asking for help. Students began to video at this time. The videos depict Victim on the ground defenseless and in pain. Defendant Kiera Smith comes over to Victim and stands over the top of him and raises both her arms up and looks down at him and says loudly, "anything else!" Defendant Kiera Smith walks away and goes to her desk. Defendant Kiera Smith does not offer to help Victim, nor does she check on him or administer first aid. Victim's mother who works at the school found out her son needs help and gets to the classroom approximately 15 minutes after the altercation. Victim is still on the ground in agony and crying, while defendant Kiera Smith is sitting at her desk.

[REDACTED] (mother of [REDACTED]) advised she transported Victim to Mercy Hospital for treatment. Victim received x-rays which depicted a broken collar bone. [REDACTED] advised the bone was broken completely. Victim was placed in a sling.

I reviewed video footage from students who took videos and it confirms the stories. I read over numerous written statements from students in 5<sup>th</sup> hour and 7<sup>th</sup> hour. Multiple students detail defendant Kiera Smith "body slamming" [REDACTED]. Other students detail defendant Kiera Smith throwing [REDACTED] to the ground of pushing him down.

On 11/25/24, I contacted defendant Kiera Smith and interviewed her over the phone. During our conversation she did not ask about the Victim's injuries or health. She seemed very put off about the situation and downplayed the altercation. Defendant Kiera Smith explained she often "play fights" the students at school. I began to ask her about the altercation, and she stated, "we, we really don't play around with Victim. He just took it upon himself to join in." Defendant Kiera Smith said she was play fighting [REDACTED] and saw Victim coming up from behind so she ducked. Defendant Kiera Smith said this caused Victim to "roll over my shoulder or whatever, and he fell on his arm." At this point I asked defendant Kiera Smith what happened after he was injured, and this was captured on cell phone video. Defendant Kiera Smith said she checked on the victim and "he moved his arm, moved his fingers, and then he started doing his work." This was not reflected in the cell phone videos. The cell phone videos also show [REDACTED] come up and kick Victim while he is on the ground. Defendant Kiera Smith does not mention this and says [REDACTED] goes and sits down after Victim is on the ground. Defendant Kiera Smith said Victim does not partake in the horse play often and he just inserts himself. I told defendant Kiera Smith that Victim broke his arm and she

told me she knew, and she checked on him. Defendant Kiera Smith did not understand why this was a criminal matter.


I looked at defendant Kiera Moore's criminal history. In Oklahoma County (CF-2018-3222) on 4/3/18 Kiera was charged with Sexual Battery and on 1/22/19 she plead nolo contendere to Assault and Battery on a Teacher (Misdemeanor).

On 11/25/24, I presented this case to Oklahoma County Assistant District Attorney R. Gray who accepted filing the above listed charges.

Based on the aforementioned, your Affiant believes Kiera Smith has violated 21 O.S. § 646 Aggravated Assault and Battery and request a Warrant be issued for Kiera Smith's arrest.
