NARRATIVE No: 1 - Officer: DAVIS, TODD

On Saturday night, May 09, 2020 at approximately 2130 hours, Deputies of the Kingfisher County Sheriff's Office were dispatched to 2484 N. 2860 road in Kingfisher County, Oklahoma in reference to someone being shot. Shortly after, Deputies were also dispatched to a roll-over wreck on United States Highway 81, north of Hennessey, Oklahoma.

When I responded to the incidents, and went to the crash scene first. As I was arriving, one of the victims of the crash was being airlifted. This victim was identified as Michael Andrew Porter. One of the Deputies told me that the driver of the Toyota pickup, Benjamin Allen Millis, was in the back of a patrol unit.

When I opened the patrol unit door and Benjamin exited the vehicle, I saw he had handcuffs on. The handcuffs were removed from Benjamin, as we did not know who or how they were involved in the incidents. I had Benjamin sit in the front of my patrol unit. I seen that Benjamin had some bloody marks on his face and asked if he had received any medical attention. He said that he had not received any medical attention and said that it would be nice to have his eyes cleaned out. Benjamin asked if we found "a big, like F-250, F-350 here too?" I moved my patrol unit over to where the Fire Rescue vehicle was parked and asked them to evaluate Benjamin.

I exited my patrol unit while Benjamin was being evaluated by Fire personnel. My audio recorder was still in my patrol unit with Benjamin. Benjamin was talking to the Firefighter and said there was a big F-250 or F-350 that ran them off of the road. Benjamin said that he "had it to the floor" doing 110 and "they slammed right in back of us and spun us out." Benjamin said that he had a boat in the bed of the pickup.

One of the Firefighters that was evaluating Benjamin asked if someone had a gun. Benjamin responded, "yeah, I did." The same Firefighter asked, "was there any shots fired?" Benjamin responded, "yeah. The guys at a house over there, tried to pull me out of the truck."

Sergeant Shults called and said he had located a white Ford pickup that had front-end damage. He said the hood felt warm and there was no one around it. I told Deputy Shults that I suspected that it had something to do with the incidents, but that I didn't know what role it played at that time.

While I was speaking to SGT Shults, Benjamin was telling one of the medical personnel what happened. I was not paying attention to this, but it was recorded on the audio recorder that was still inside my patrol unit. Benjamin said, "I sat there a couple of minutes and they were saying something about getting a gun and shooting all of us". Benjamin said, "they chased us down, down a gravel road, up the highway, back down the highway, I went down somebody's driveway, I thought it was a road, back out on the highway and there they ran us off the road."

I got back inside my patrol unit and let Benjamin know that I had an ambulance coming for him. Benjamin provided me with his name, date of birth, address, and phone number. I asked Benjamin what happened. Benjamin asked if this was an official report here or.. I told him yes that it was an official report, I told Benjamin that I didn't know who victims or suspects were and that is why he was not in handcuffs. I told Benjamin that I didn't know what he had to do with it.

Benjamin said, "as complicated as all this stuff is.. is it, I don't know that it's a good idea to be talking about it." I responded with "okay." Benjamin replied, "I could straight up tell you exactly what happened.... But, I mean I know how that goes." I told Benjamin that I was trying to figure it out.

I asked Benjamin where he was at in the vehicle? Benjamin said he was the driver. Benjamin said that the Toyota pickup was his vehicle. I asked who the front seat passenger was and Benjamin said his wife, Bobbie Jo was. I asked who else was in the vehicle? Benjamin said his 4 year old daughter was in a car-seat on the passenger side, in the back. I asked if that was all and Benjamin said no. Benjamin said Michael Andrew Porter was on the driver side in the back seat.

I am changing the format to make it easier to follow:

DAVIS- So which way were ya'll going?

BENJAMIN- We were southbound at the time. Trying to get away from the F-250 (something inaudible)

DAVIS- So ya'll were going southbound towards?

BENJAMIN- When we, when we first got on 81, we ran north and.

DAVIS- Okay, where did ya'll get on 81 at?

BENJAMIN- At Marshall road I believe. Within a mile of Marshall road, I believe it was Marshall road.

DAVIS- Okay, Marshall road.

BENJAMIN- Well there's that blacktop that's what a mile south of there? That may be the one we took. But, we jumped on 81 and went north. And, man I'm losing order here. There was a driveway, long gravel driveway with a curve, I thought it was a road, we went down there, I can't remember if it was after we turned around or not. I think it was before. But, went down there, turned around, people's yard because I thought it was a road and went back out. Missed both of the vehicles that were chasing us. I never saw what the second one was, but one was a big, brand-new looking 250 or 350, big lifted truck.

DAVIS- Did you know them?

BENJAMIN- No. No idea who they are.

DAVIS- Okay.

BENJAMIN- And got back on 81 and went north. We were trying to, my wife was trying to get a hold of the Police and we were hoping they could catch us in Waukomis or something, but they were catching up on us way too fast, so I turned around at Bison.

DAVIS- When did they start following ya'll?

BENJAMIN- On Cleveland road.

DAVIS- so..

BENJAMIN- Is where all the people were over there, then all that happened. We, we were headed home, straight up north on Cleveland from 51, headed home. And somebody in the front yard of the place threw something big, it sounded like a rock, like that big.

(someone opened my rear door to put tape in my back floorboard and I told them that I appreciated it)

DAVIS- So you were, so you were going home on?

BENJAMIN- Cleveland road.

DAVIS- Okay.

BENJAMIN- The road we live on.

DAVIS- Okay.

BENJAMIN- We passed this house and they threw something. Looked like a rock, I could see it coming, it looked like, seriously that big, slammed into the side of the truck. So I stopped and backed up to see...

DAVIS- Right.

BENJAMIN- What in the world that's about. And that's where all that happened.

DAVIS- Okay, so what, what happened?

BENJAMIN- Well, I don't know if we should discuss that. I mean, I feel like I am completely in the clear but I know how stuff gets (inaudible).

DAVIS- Okay and that's what I'm saying, is I don't know, I don't know what happened.

BENJAMIN- Right.

DAVIS- Okay. I don't, I don't know what happened. I don't know, I don't who victims are. I don't know who aggressors are, that's the reason why, that's the reason I had you taken out of handcuffs, is because we don't know. Do you know what I'm saying?

BENJAMIN- After what happens there, we sat there a couple minutes and then they started yelling to grab a gun and shoot us all.

DAVIS- Okay.

BENJAMIN- And so, wife and friend Michael in the backseat said dude, we got to go we'll just call Police and, and figure it out somewhere without all of us dead.

DAVIS- mmhhmm

BENJAMIN- So, we hauled ass and wife started trying to get a hold of the Police. And, and then it went from there to here.

DAVIS- Okay, okay. Where were ya'll, where were ya'll going home from?

BENJAMIN- Canton Lake. We had been fishing.

DAVIS- Oh okay. So ya'lls just on the...

BENJAMIN- We were just headed home. We come down 51, go straight up Cleveland, right there.

DAVIS- Okay.

BENJAMIN- If you find my phone in there, there's pictures from the lake on it (something inaudible)

DAVIS- Okay. Did you turn around or did you just back up when you stopped?

BENJAMIN- What at the house over there?

DAVIS- Yeah.

BENJAMIN- I backed up just a little ways.

DAVIS- Okay.

BENJAMIN- I couldn't see to turn around. I don't even know (something inaudible)

DAVIS- Do you know those people?

BENJAMIN- I have no clue who they are.

DAVIS- Okay.

BENJAMIN- never met them.

DAVIS- Did ya'll start arguing? Did you ever get out of your vehicle?

BENJAMIN- They tried to pull me out of my vehicle. Yanked my door open. There's like ten of them trying to drag me out, the only thing that kept me in was my seatbelt.

DAVIS- Okay. So they came around. They came around

BENJAMIN- No I backed up. I was headed north. Their place was on the driver side.

DAVIS- Okay, so they were all, they would be on the west side.

BENJAMIN- And I just backed up and rolled my window down, and they walk over there. They just go to yank me out of the truck. Like yank, literally yank my door open and there's like, piles of guys, big guys too and they're, as many as could cram in the doorway trying to drag me out of my door.

DAVIS- Okay.

(I checked on the ambulance that was on it's way for Benjamin and they were still on their way. I was updated about where Bobbie Jo and 4 year old daughter were going.)

DAVIS- So how did you wind up here though?

BENJAMIN- They chased us in a big lifted F-250 or 350. I could recognize it by the headlights in the back window.

DAVIS- So you stopped there, backed up. Did they just rush the vehicle, or?

BENJAMIN- Yeah, yeah. Like I didn't even have time to put it back in drive and they were yanking my door open.

DAVIS- Okay... Okay what happened?

BENJAMIN- You know I don't know that it's a good idea to go into detail.

DAVIS- Okay. Just whatever you, whatever, whatever you feel comfortable with.

BENJAMIN- Yanked my door open and at least, at least four of the guys that were up there had a hand on me just dragging me out of the truck. Like collar, neck

DAVIS- Okay.

BENJAMIN- Everything they could grab was just yanking me out of the truck like I was seriously pissed them off.

DAVIS- Right.

BENJAMIN- I assume they thought I was driving too fast or something, is why they threw the rock at me in the first place, they were just pissed about that.

DAVIS- Okay.

BENJAMIN- But, I wasn't going that fast.

DAVIS- Right

BENJAMIN- It's a gravel road at night. I was probably going 45 or 50.

DAVIS- Right

BENJAMIN- And then I just. (inaudible) my only option.

DAVIS- Okay. Okay.

BENJAMIN- I have no doubt they would have pounded me into the ground right there, the way they were acting. That many people, I had no chance.

DAVIS- Okay.

BENJAMIN- I think it was Bison Co-Op that we turned around at and headed back south. I think we were headed south.

DAVIS- Okay

BENJAMIN- We were limited out at 110. I couldn't get it to go any faster. And they hit us hard, even at that speed.

DAVIS- Okay.

BENJAMIN- And I couldn't keep it on the road.

DAVIS- Okay.

(Chief Weber asked if we still needed the Fire Department and that he was going to try and get as many people out of there as he could.)

(Deputy K. Thompson had arrived and I had him come over to my patrol unit. I introduced Benjamin to Deputy Thompson and then began to go over the details with Deputy Thompson while Benjamin listened and verified.)

DAVIS- Your'e the driver, okay, you had your wife as the front seat passenger, Bobbie Jo. And then your daughter, how old was your daughter?

BENJAMIN- She is four.

DAVIS- Four. Okay, she was in a car-seat in the back passenger seat, correct?

BENJAMIN- Yes

DAVIS- And then the back driver seat passenger was a Michael Andrew Porter and he was the one that was mediflighted, correct?

BENJAMIN- Yes.

DAVIS- Okay, so you umm, your'e going home from the lake right?

BENJAMIN- Yes.

DAVIS- Okay. Ya'll turned onto Cleveland off of 51.

BENJAMIN- Yep.

DAVIS- Okay. It turned to gravel.

BENJAMIN- Yep.

DAVIS- Passed a house that he threw something at you.

BENJAMIN- Yep.

DAVIS- Did it strike your truck?

BENJAMIN- Yeah. It hit hard. Like a big rock.

DAVIS- Okay. So you stopped. Backed up, and then from there.

BENJAMIN- I bet I only backed up like maybe from where the truck is to where you are, it wasn't far, because I

wasn't going that fast.

DAVIS- And where the people approached you from was on the driver side.

BENJAMIN- Yeah.

DAVIS- That was the same side the house was on.

BENJAMIN- Yeah.

DAVIS- Okay. So once they started, once they approached your driver-side, that's when they started yanking the door open.

BENJAMIN- Yeah.

DAVIS- Okay.

BENJAMIN- Like a bunch of guys rushed it all at once.

DAVIS- Okay.

BENJAMIN- Just yanked the door open and started dragging me out of the truck.

DAVIS- Okay. And you had your seat-belt on?

BENJAMIN- Yeah. That's the only thing that kept me in there.

DAVIS- The only thing that kept you in there. Okay. What, what year model is your truck?

BENJAMIN- It's a 2015.

DAVIS- 2015. Does it have power, uh locks and windows?

BENJAMIN- Yeah.

DAVIS- Okay. Whenever you put your truck in drive, does it automatically lock the doors?

BENJAMIN- yeah. Mmmhmm.

The ambulance arrived and medical personnel began to evaluate Benjamin.

I took photographs of the Toyota pickup. Eight of the photographs were of the exterior of the pickup and showed how it came to rest on it's side in the field. Eleven of the photographs were of the interior of the pickup and the .22 caliber Ruger pistol with attached suppressor that was inside the Toyota pickup.

The pistol was under some loose papers that was in the pickup. I photographed the pistol before removing it. The magazine was not fully seated into the magazine well and the slide was already locked back. I removed the magazine from the gun and there were no bullets in the magazine. As the slide was already locked back, I could see there was not a bullet in the chamber. There was another empty magazine in the driver-side floorboard and a .22 caliber bullet on the driver-side A pillar. I collected these items, placed them into evidence bags and then secured them in my patrol unit.

I left the crash scene and went to 2484 N. 2860 in Kingfisher County. I approached from the north, and while driving south on CR 2860, I was looking at the roadway for any noticeable disturbance in the gravel. I was looking for indications of "hard braking". If someone were to be at a higher rate of speed and slam on the brakes, the sudden transfer of weight, combined with the loose gravel surface, would more than likely leave an indication of this by displacing loose gravel. Similar to someone that heavily accelerates from a complete stop on loose gravel, the tires will spin, and gravel will be disturbed, leaving an indication of this. The only disturbance in the gravel that I seen was from heavy acceleration and the tracks that left these marks came from the yard/drive of the residence that is on the west side of the roadway. (On one of the recorded 911 calls, you can hear a vehicle heavily accelerating as it is leaving to give chase. I suspect that is what these marks/disturbance in the gravel are from.)

Deputy C Countryman informed me that he had taken photographs of the beer can that was in the roadway and the spots of blood that was in the roadway. I provided Deputy Countryman with numbered placards and asked him to take more photographs and collect the blood as it was beginning to sprinkle.

I spoke with John Gritz and asked him to explain what had taken place that evening. John explained that it was his son's, Trevor Gritz house and they were there earlier in the day for his grandson's birthday party. John said that he had went home earlier and that he is also the Fire Chief for Hennessey Fire Department and the Mayor. John said that he received a page but there was no voice message. (referring to a fire page out)

John said someone that was at Trevor's house had called him and said they needed help getting an ambulance out to Trevor's house. John asked what had happened. John said he was told that a pickup had pulled up and shot Chris. John said the tone did come through and he got into his pickup and went to Trevor's house. John clarified that he was not at Trevor's when any of this took place. I asked John if there was anything that he has overheard that might be pertinent to me? John said he was told "was that this pickup kept speeding by and there were kids they, when we were here earlier, they were playing in the mud in that ditch." They were talking about how cool it was before he left, that the parents were letting their kids play in the mud and not worrying about them getting dirty. John went back to telling me what he was told, "this pickup kept speeding by, is what I was told, at a really high rate of speed, and he uhh. My son apparently chunked an empty beer can at him and uhh, the guy stopped, and uhh, they come up here and he pulled a gun. And they said it was a pistol with a silencer, but I'm understanding you guys just found a rifle."

I was informed there was a pickup on the property and that it appeared to have recent damage to the passenger-side front quarter panel. I went to speak with Trevor Gritz. Trevor consented to us being on his property. Trevor informed me they were celebrating his son's birthday earlier in the day. We were walking next to a Chevrolet pickup and I looked at the front quarter panel. Trevor said it was Levi's pickup and that the damage was already there. Trevor also said Levi wasn't there "when all of this happened."

Trevor and I went to my patrol unit and he provided me with his name, date of birth, address, and phone number. I asked Trevor if he could explain to me what had taken place today.

TREVOR- We were all hanging out, well like I said we were having my son's birthday party and this, that pickup come by, earlier this afternoon, northbound

DAVIS- How, how, how much earlier?

TREVOR- Oh I don't know. Five o'clock, six o'clock probably I'm just guessing. He came by three different times.

DAVIS- Okay.

TREVOR- And maybe the first time was, earlier, three or four, it was a couple hours in between each time. And anyways, the second time he come by, we all screamed slow down, slow down. Well then that third time, is when he came by again, and I threw uhh, beer, we were all standing by the burn-pit right there. *(Trevor rights in his written statement that it was the fourth time he drove by is when he threw the beer can)*

DAVIS- Uhh huh

TREVOR- And I threw a beer can out there, and he stopped, probably pretty close to right here.

My patrol unit that Trevor and I are in is just north of his north driveway and he relates our location to being close to

where the Toyota pickup stopped. This is approximately 140 feet north of where the fire-pit (landmark) was positioned in the yard. This is a key piece of information as the investigation goes on and I didn't realize it at the time I was speaking with Trevor. In my personal experience and law enforcement experience, I know that people who are on or within their property daily and have subconsciously familiarized themselves with "landmarks or surroundings" over a period of time have a more accurate sense of "place", therefore have a more accurate description in relation to location/distance as it pertains to their property.

Witnesses said the pickup was excessively speeding. Some of the witnesses have described the approximate location of the vehicle stopping as, "finally getting stopped at the neighbors 1st driveway", "came to a stop aprox 300 yards north of incident", and "once they got it shut down which was 1/4 mile at least from us they came to a stop".

I find it extremely difficult, if not impossible to be speeding, react to an object hitting your vehicle, and then stopping your vehicle within approximately 140 feet and not leave any marks or any indications of heavy braking. Therefore, I believe Benjamin was not driving excessively fast. Whether or not the vehicle was speeding is not what I am shedding light on, I am showing that witnesses and now possible suspects appear to be embellishing on the speed of the vehicle in an attempt to justify their actions or the actions of their friends/family.

We know that there was indication of something that happened on the roadway near where the blood was on the ground. It looked like it was from something that drug the ground, such as feet or other objects. This just shows that the gravel/dirt was loose and could easily be moved. If an object such as feet could disturb the gravel and leave those marks, then surely a rapidly decelerating vehicle that was speeding would leave some sort of disturbance in the gravel.

DAVIS- Okay.

TREVOR- And uhh, anyways and he threw it in reverse, so we all come like running over here. Like, cause all of the kids are out here. You know what I mean?

DAVIS- Right.

TREVOR- So anyways we come out here, and like he opened the door up. And, uhh he pulled out a gun and uhh, he point, pointed it straight in my God damn face and then Lane, my buddy was like you gonna, really you gonna fucking shoot me?! This and that and then Chris grabbed that gun and it, shot him, (Trevor made a soft pew pew sound) two or three times. Then uhh, the guy sat there, the, the guy that shot him, like he sat there and everybody started calling the cops and everything and, like he sat there for a minute. Like

(A wrecker driver arrived and I had to roll down my window to speak with him.)

Trevor said that he didn't know when Lane left. Trevor knew Chad and Jarod had left before the ambulance arrived.

Trevor's statements described their positions at the opened door and how close they were inside the open door. Trevor originally stated twice that Chris grabbed the gun and then changed it to he may have tried to grab the gun. During this interview, I observed several factors of deception.

Before speaking with Levi, I spoke to Troopers and other Deputies. They suspected the damage on Levi's Chevrolet pickup was fresh. I spoke with Levi Copeland. He provided me with his name, date of birth, address, and phone

And, I said hello, he said I need help, I need help, I said okay, what's going on? Chris is shot. They fucking shot Chris. I God damn fucking followed em and, they stopped, I ran into em. Trevor's truck is fucked. I was like what. Stop. Wait, and so he ran through it all again, same practice. I said stop. Where are you at? The truck is sitting at Caleb's. I'm walking back to Trevor's, I got to find out what's going on. I said alright I'll leave. I got my shoes and I left. I told my girlfriend I was leaving. I called him on my way here. I got coming here and I seen everybody was here, I seen everybody on the highway. So I called him and I said where are you at? He says I'm walking towards Trevor's. I don't know where you're at. I said I'll try to find you and I have his location, so I found him. So what are you doing? I got to get to Trevor to see what is going on. I said where is Trevor's pickup? It's right here at Farmer's. So let's go get it and take it back home. Okay, so we get it and he drives it and it's parked back there where it sits.

said it was from a couple of years ago. Levi gave written consent to take his pickup and examine the damage on the passenger front. Levi retrieved anything from his vehicle that he needed and a Trooper requested a wrecker for the vehicle. *(It was later determined that this vehicle was not involved in the incidents.)*

I spoke with Jarod Dowell. He provided me with his name, date of birth, address, and phone number. I asked Jarod to explain to me what had taken place that night.

JAROD- (Big sigh) Well, obviously my friend got shot and killed right there, and from there, I took off trying to catch them to get the tag number, and when I was finally catching up to them, they had slammed on the brakes and I hit them at Bison. And then from there, I don't know what happened.

DAVIS- Okay. What took place, how long have you been out here today?

JAROD- I got here about 4 o'clock or so.

DAVIS- Okay. So 4 o'clock

JAROD- We was here for a birthday party for my buddy's, little boy.

DAVIS- Okay, okay. So what lead up to the shooting?

JAROD- That guy had been by here, sixty or seventy miles an hour it seemed like, about three or four times.

DAVIS- Was that, how, how many, how long in between each time?

JAROD- Between fifteen and twenty minutes it seemed like, maybe, probably. *(This is no where close to what Trevor said. I suspect that this is another person attempting to justify their actions.)*

JAROD- He said something about his transmission being out or something. So I don't know what happened. That was the last time I talked to him.

DAVIS- Did he say where he was at?

JAROD- No.

Jarod agreed to call Chad and try to get him on the phone. Chad never answered. *Jarod was extremely vague and evasive during his interview.*

I spoke with Taylor Black. She provided me with her name, date of birth, address, and phone number. I asked Taylor explain what had taken place. Taylor said she was inside when everything had happened. Taylor said when she went outside to check on what was going on, she seen Chris laying on the ground. Taylor said she is the one who was counting the chest compressions during CPR.

I spoke with Stephanie Dowell. She provided me with her name, date of birth, address, and phone number. I asked Stephanie to explain what had taken place that evening.

STEPHANIE- We were standing by the fire that we just got started, with everybody, even the kids were over there. Um, truck was coming down the road really fast, um, everybody started yelling at him, telling him to slow down, um, he got to kind of around here, hit his brakes, reversed. The guys were walking this way, um, we were getting the kids in the house, we heard something. I couldn't tell if it was a gun shot, but then we saw Chris and we ran and got the kids in the house.

DAVIS- Okay.

STEPHANIE- Um, I told Taylor, um I said I, he wasn't, I couldn't tell if he was breathing, so she ran out cause she is a teacher and she wanted to make sure that they were going to start CPR or whatever. And I stayed in the house until the ambulance got there.

DAVIS- Okay, okay.

Stephanie said Mallory was the one who was doing CPR. *In her verbal statement, she used our location (my patrol unit) as a reference to where the pickup "hit his brakes and reversed." In her written statement, she writes, "the truck pulled passed drive." Both of these indicate that the pickup stopped near the location that Trevor designated as well.*

Once it was daylight, Deputy Thompson and I went to try and locate Chad's F-250 pickup. I went back to the area of the crash site and could see a trail of fluid that started at the point of impact on US 81. I followed this trail of fluid south to CR 610. The fluid trail went west on CR 610. At the railroad tracks there were chrome pieces that looked like they had fallen from a vehicle. There were several fluid spots on CR 610 and the trail continued to go west. Deputy Thompson and I continued to follow the trail. The further west we went, the fewer drops of fluid we seen, and the further the distance between the spots. We reached an intersection a few miles west of US 81 on CR 610 and we were unable to tell which way the damaged vehicle had went.

On the morning of May 10th, Deputy Thompson and I went to Chad and Samantha Dowell's residence on CR 2880 in Kingfisher County, OK. I rang the doorbell and Samantha came to the door. Samantha went to get Chad and he came outside. I asked if Chad would come to my patrol unit, so we could talk. Chad said he could talk to me on his porch and I said okay. I asked Chad if he could tell me what happened last night.

CHAD- Motherfucker came by and shot Chris Robinson, twice.

DAVIS- Okay. What happened before that? What, what kind of lead up to that I guess?

CHAD- Oh, he come, he come by hauling ass, blow hard, slow your ass down, this guy had a boat or something in the back, he backed up, and we were walked out there and he (inaudible) door open and that guy had a 22 or something. Shot him twice.

CHAD- (inaudible) going out there.

CHAD- Yeah I come home.

Deputy Thompson says we'll just come back with a search warrant. I turned my recording device off while walking to my patrol unit and heard Deputy Thompson talking about a search warrant so I stopped and turned my recording device back on and walked back towards the porch. Deputy Thompson then begins to walk towards me so I turn back around to go back to my patrol unit.

Samantha came out to where Deputy Thompson and I were parked and said she didn't know why Chad was acting like he was. I explained to Samantha that we were just trying to figure everything out. Samantha asked if she could try to get through to him and I said absolutely. I asked Samantha how far west the vehicle was and she said "like four miles." Samantha didn't know what county road it was on. She said she would be right back and went into the house.

Samantha came out a few minutes later and asked if we wanted to follow her. I told her yes we could follow her. Samantha showed us where the F-250 Ford Platinum was parked. She drove straight to the pickup. The closest intersection is CR 2830 and CR 590 in Kingfisher County. There is a dirt trail approximately 200 feet south of that intersection that goes east. The F-250 was parked approximately 1,200 feet east of CR 2830 on the north side of the dirt trail. I could not see the pickup from CR 2830 when driving. The terrain sloped down and the grass was tall.

The black F-250 Ford Platinum pickup bearing Oklahoma license plate IDF479 had damage to the front-end of the vehicle. I could see there was fluid that had leaked from the front and had blown down the sides of the vehicle. There was a chain still attached to the passenger side, front tow-hook.

I thanked Samantha for showing us where the vehicle was at and she asked if we wanted them to leave the vehicle there or did we want them to take it to their house, now that we have seen it. Deputy Thompson informed her that she could take it to their house, but to not make any changes to it. During our conversation, Samantha stated, "and I'm trying to figure out if Chris opened, because I, he went to his pickup and opened his door or not, or if the guy opened the door. I can't, I keep playing that in my head." Deputy Thompson explained that he thinks it happened so fast. Deputy Thompson, speaking to Samantha says, "I do believe that Chad is kind of downplaying it a little bit, because he said we walked out there and at the same time you said, they all, they all rushed out there." Samantha replied, "they did." Samantha then stated, "I went inside and went Chad why didn't you tell them I brought you home?" "He said, I didn't want to get you in trouble." Samantha said that she was the one who took Chad home. Deputy Thompson asked Samantha if she knew how many trucks left the house to give chase. Samantha said there were two, Chad and his brother (Jarod).

I took photographs of the vehicle. I asked Samantha if she knew who pulled the truck there and Samantha said she did. Samantha said she didn't know what he was thinking. Samantha said they pulled it there and then went home. We left the truck there and I notified Lieutenant Weimer of the Oklahoma Highway Patrol that we had located the pickup and that it had front-end damage. LT. Weimer asked if someone could stay with the pickup while he obtained a search warrant for the vehicle.

I went back to CR 2830 and waited for LT. Weimer to arrive. While we were parked on CR 2830, the land owner pulled up to us and said we could go onto his property. He went down to the pickup with us and then he left shortly after. LT. Weimer informed me that he had received the search warrant. Southside Wrecker Service arrived and took possession of the pickup.

On May 12, 2020 at approximately 1445 hours, Lane Green and Mallory Craig came to the Kingfisher County Sheriff's Office to speak with me. I spoke with Lane first. He provided me with his name, date of birth, address, and phone number. I asked Lane to tell me about the other night at Trevor's.

LANE- So whenever the pickup actually came by, I was standing at my pickup on the north side of his property there. The pickup was flying by and I heard everybody hollering, you know slow down and everything, and I seen them stop. I was at my pickup getting a beer and peeing over there, and uh they sat there for a while. And I'm like well they stopped, now they're going to keep on going. Then they backed all the way up, and then as Trevor was headed out and then uh, Christopher was headed out, I was walking behind them and as I got to the corner of the pickup, it was like a Toyota extended cab or whatever, and the driver door, window door, driver door window was down and the back window was down and I could see he was waiving a gun around and then that's whenever I hollered he's got a gun and I took off the other way. The next thing I know, I don't know if Chris opened the door or that guy had opened the door, but Chris was trying to get it from him in there and then he fell back and hit the ground and, and that's, I immediately turned around and started puking because I just watched my buddy get shot and then the next thing I was trying to get my phone out to run out there and take a picture of the license plate because they were, I figured they were about to haul ass and, that's when they did. And then um, my girlfriend, which she's outside, I brought her because she was doing, she started doing CPR on him, and um, they took off to the north, I'm still trying to gather myself and everything else and um, Jarod Dowell and Chad took off chasing them and then it was a few minutes later, Sam Dowell got a phone call and told me that I needed to go pick up Chad, uh from, it would have been the corner south of Ranger and back to the west a little bit, his transmission went out. So I left, just, I know I shouldn't have, I left and I went and got him and I took him home and then I left there and went to my parent's.

DAVIS- Okay. Okay.

LANE- But as far as, I've heard, like Trevor said that there, somebody was taking a video. I didn't see anything or anyone but like the driver, and I seen the gun barrel, waiving around and that's whenever I turned around and hauled, I was getting the hell away from there but. Somebody said that there were four people in there. I don't, I couldn't tell you how many, people were actually in the vehicle or anything.

DAVIS- Okay. So, you're already, your truck is parked where?

LANE- It is there at Trevor's on the, he's got like a row of cedar trees on the north side of his property there and my pickup was parked there. And whenever they went by, I was over there on the north side of my pickup, between my pickup and the trees, pissing and getting a beer. And uh, I heard everybody hollering, and I guess, Trevor or someone threw a beer at them. I don't know, I was over there, I just heard the hollering, and that guy finally got stopped up there, up the road by the neighbor's driveway, and then they sat there and I could see them through the trees setting there for a while, and then they started backing up and that's whenever, everything had happened.

DAVIS- Okay. Okay, so he backs up. What happens after that?

LANE- He backs up. Trevor and uh Christopher were headed out there and I was behind them, and then as Trevor was by the mirror of his pickup there, the driver side window was down and the extended cab part door was down. Him and Chris were up there and I could see through the extended cab window, that was down, that he was waiving a barrel of some something around. I don't know then, who, whether it was Chris that opened the door or the driver opened it, but I was hauling ass at this point. I said he's got a gun and, next thing I know, I guess Chris was trying to take the gun from him and that's when he was shot and stumbled back and hit the ground. And then I turned around and started puking.

DAVIS- Okay. So you seen Chris and him struggling over the gun?

LANE- Yes. I could see, well I could see, his back, Chris's back inside the door of the pickup trying to take it from him. Struggling to get it.

DAVIS- Okay. So both windows were rolled down?

LANE- Yes. On the driver side there. It was like a, like the small extended cab, Toyota Tundra or whatever the hell they are, but yeah.

DAVIS- Okay.

I drew a top-view sketch of a vehicle and asked Lane to show me where people were at in reference to the sketch. Lane said "I just know Chris was in the door, and that guy was still in his pickup also, and then Trevor had to have been up in front of it and I was headed back this way." Lane said when he seen the gun, he took off running towards Trevor's house.

DAVIS- Was there words exchanged?

LANE- Uh, Trevor as they walked up there, Trevor told him you need to slow your fucking, uh slow your fucking ass down or something like that. And then it went str, I never heard the guy say anything. I don't know if he ever did talk. All I know is that, I heard Trevor say that, and then I seen the gun, and that was all that I, you know put together of it. I couldn't hear anything else. I probably wasn't even close enough to hear that guy, if he did say something, I never heard him.

DAVIS- Okay.

Lane said he had only been at Trevor's for approximately an hour and a half and within that time, there had only been one other vehicle drive by. I asked if that was the only time that pickup had drove by while he was there and Lane said that it was. Lane said he went to get Chad and he left before the ambulance arrived. Lane said Chad didn't say anything to him until they got to Chad's house. Lane said Chad told him that he was going to fast and ran into him. Lane said they left Chad's truck on CR 610 just west of US 81. Deputy Thompson asked if the door was open when he seen the gun and Chris said that it wasn't. Lane said Chris was on the outside of the door. Lane said when he seen that he had a gun, he ran the other way and by the time he turned around, is when he heard the gun shots, seen that the door was open, and Chris trying to take the gun. Deputy Thompson asked Lane why he thought Chris tried to take the gun and him not just leave the truck. Lane responded, "I don't know, Chris was a tough guy. Now it costed him his life instead of just leaving it alone." I asked what he meant by Chris not just letting it go and it costing him his life. Lane replied, "Instead of just letting it, like backing away from the vehicle and letting them leave or you know whatever instead of trying to fight him for the gun, taking it away from him, you know. That he got shot, if he would have just probably not tried to have taken it, uh I mean, he probably wouldn't have got shot then." Lane said he didn't know why the guy pulled the gun out.

I handed Lane a voluntary statement form and he filled it out while we spoke with Mallory. Mallory provided me with her name, date of birth, address, and phone number. I asked Mallory to tell us what happened the other night and she asked where I wanted her to begin. I said wherever she would like.

MALLORY- Saturday night, uh we went to our friends house, Trevor his kid was having a birthday party. A lot of our friends were there, so it started to get kind of dark and cold so we started a fire in the front yard, and um, this pickup just flew by at least 60 maybe 70 MPH and everyone kind of you know, hey slow down, there's kids. And, then they stop, down the road, a while down the road I mean, and then sat there for a minute, started to back up and come back. And when they came back, I just thought ah there's going to be a fist-fight or something. Well I heard gunshots and it kind of took me a second to realize, and Lindsey said, those are gunshots. So we yelled at the kids get in the house and started off, taking off towards the pickup. I seen Chris, kind of step back and fall hit the ground and as I'm approaching the vehicle, where everyone is, the back, the driver's backseat door is open. So the dome-light's on in the pickup. I see, the pickup was full, three or four adults, at least four, I saw four adult heads. And I could just hear a woman screaming, and then they slammed the door and took off, and that's when I just um, got down and started working on Chris. And I worked on him until Paramedics got there and then I helped them, and that was it. I heard the gunshots, at least twice, I think three times, and he had I know he had one in his upper right chest, his left

shoulder, for sure, and and that's all I can say for sure that I saw.

DAVIS- Okay. And where were you standing at?

MALLORY- When it happened?

DAVIS- Yeah.

MALLORY- I was standing by the fire.

DAVIS- Okay.

MALLORY- When they had reversed back and stopped, and the guys kind of took off over there. A couple of the kids, older boys wanted to walk over and I said, no don't go over there, you know, thinking their probably going to have a fight or yell at them or whatever. And then it was then that we heard the gunshots, so I was standing by the fire.

DAVIS- Okay.

MALLORY- And the pickup sat there for, seconds I'm sure, it seemed like longer, but they were still there when I was approaching, when I was running up there you know to see if it was Lane or see who it was and that's when I seen Chris hit the ground. And they sat there for, I don't know why they were still sitting there for a few seconds. The back driver door was open, and then they slammed it and took off.

DAVIS- What lead you to believe that there was going to be a fist-fight?

MALLORY- Um, well the fact that the pickup went by, I don't know why they came back, but I just thought since we were all kind of yelling, hey slow down, they came back, reversed back and then, some of the guys started walking up to the pickup. And I just, I just assumed you know, worst of the worst, there might be a fight, which is why I told the kids don't walk out there.

Mallory was given a voluntary statement form and she provided a written statement.

On May 13, 2020 I obtained a search warrant for the Toyota Tundra pickup that was driven by Benjamin. I had this pickup moved from Southside Wrecker Service to the Sheriff's Office secured garage and Deputy Thompson and I executed the search warrant. I requested the Fire Department assist in removing the top of the pickup. This vehicle had rolled over during the crash, causing the roof to partially collapse. There was blood on the side curtain airbags and some of the doors would not open, which would make it extremely difficult, if not impossible to thoroughly search the vehicle. I photographed the vehicle before the top was removed.

Once the top was removed and the doors were opened. A black Iphone with black Pelican case fell out of the front driver side opened door. I photographed this phone and collected it as evidence. There was a black Iphone with a blue and clear case in the front driver seat. I photographed this phone and collected it as evidence. There were a total of 473 .22 caliber bullets and 04 .22 caliber magazines collected from the vehicle. These items were secured in an evidence locker at the Sheriff's Office. There were loose items in the vehicle and the vehicle rolling over caused several of the loose items to come to rest under the seats, dash paneling, and under the carpet of the vehicle. The front seats and front portion of the carpet were removed. I could not see down inside the air conditioning/heat vents. I had requested the use of a camera snake from another agency and it would be available the following day. I secured the garage and exited at 2305 hours.

On May 14, 2020 at approximately 1321 hours, Deputy Thompson and I resumed the search of the vehicle and used the camera snake to view some of the areas under the dash and in some of the air vents that the camera snake would fit in. We were waiting on Trooper Ledbetter of the Oklahoma Highway Patrol to execute his search warrant for the data modules within the vehicle, before we further searched under the dash area. We secured the garage and exited at approximately 1503 hours.

On May 19, 2020 Deputy Thompson and I went to OU Medical Center to speak with Michael Porter. Michael was the backseat passenger in Benjamin's pickup. Michael was not able to open his mouth, due to it being wired shut. I handed Michael a notepad so we could communicate in writing. Michael wrote that his vision and thinking were still a

little blurred from yesterday's surgery. Deputy Thompson asked Michael if he had his phone that night and if he was recording. Michael said he believed he got a "twenty second clip". Michael said his combination to his phone were all ones. I asked Michael if we could search his phone to look at that video and Michael said that we could. Michael said he didn't think the video showed the shooting part. Michael said both driver-side pickup doors were opened from the outside. I asked Michael if I could take photographs of his face and he consented. I took two photographs of Michael's head. We left a voluntary statement form with Michael.

I reviewed the video from Michael's Iphone once I got back to the Sheriff's Office. I video recorded this as well. The video starts and you can see that Christopher is still standing inside Benjamin's door. Trevor is standing at the B pillar as he described. As soon as the video starts, you can hear a child screaming and crying. You can hear people screaming in the background and someone saying to call 911. You also hear Bobbie Millis making her 911 call requesting an officer. A female's voice asks, "what did you do?" Benjamin replied, "they were trying to drag me out of the truck." The video shows a spent shell casing on the armrest of the center console. There is also a penny laying next to it. Due to my training and experience with firearms and handling of the ammunition, combined with the penny as a size reference, I believe this spent shell casing is of a .22 caliber. The location of the shell casing shows that it is most likely from one of the rounds that was fired into Christopher, due to where it came to rest. You can see in the video, the spent shell casing fall towards the backseat as the armrest is raised to open the center console.

On May 19, 2020 at approximately 1354 hours Deputy Thompson, Trooper Ledbetter, and I went to the garage where the Toyota pickup was being stored and Trooper Ledbetter executed his search warrant. Deputy Thompson and I assisted Trooper Ledbetter in removing some data components of the vehicle. Once Trooper Ledbetter was done, Deputy Thompson and I searched under the dash and were unable to locate any other evidence.

Benjamin's Attorney, JD White had requested to retrieve some personal items from the Toyota pickup. As Deputy Thompson and I searched the vehicle, we set aside personal items that were not deemed as evidence and what we thought were items that the Millis's would need. On May 27, 2020 Deputy Thompson and I, along with other Deputies went to the garage to put the items we had removed from the vehicle back inside the vehicle, such as, seats, trim panels, carpet, and roof. I had collected all of the items that we set aside for the Millis's and then stored them at the Kingfisher County Sheriff's Office. On June 03, 2020 JD White came to the Sheriff's Office and took possession of the personal property that we collected for them.

On the morning of June 25, 2020 I went to meet with Michael Porter at his residence in Logan County, OK. Michael's wife, was also present for this interview. Michael said the doctors had told him that when he arrived at the hospital, he was losing blood faster than they could pump back into him. Michael said the doctors told him it was a miracle that he was alive.

Michael said that he didn't have any memory loss and he could still remember things from his childhood. I asked Michael to tell me about the day leading up to the accident. Michael said he went to Waukomis to meet up with his friend and his family to go fishing at Canton Lake and left at approximately 3:00 p.m.. Michael said they fished at the lake and then left the lake at approximately 8:30 p.m., and said that it wasn't dark yet.

Michael said they turned off of the highway onto a "back road" that was two or three miles from his house (referring to Benjamin's house). Michael said they drove passed a house that was having a party. Michael said the people were "pretty much in the road." Michael said as they drove by, it sounded like they hit something or something hit the truck. Michael said they didn't know what happened, so they slowed down and Benjamin rolled the window. Michael stated that Benjamin stopped and asked the people if they hit something. Michael said he believed the people were "drunk."

Michael said he believed there were approximately 12 to 15 "guys" out there. He said there were women there, but they were more towards the back. He said when they pulled over, it was mostly all guys standing there. Michael said they went "berserk" and when Benjamin rolled the window down and started talking to them, one of them put his hand in the window and was able to get the door open somehow. Michael stated "they started to try and drag Benny out of the truck." Michael said they didn't know what was going on and why this would be happening. Michael said his door came open and they were trying to drag him out as well.

Michael said that when him and Benjamin were being pulled on that he heard someone in the background say something along the line of "drag out the guys, take care of them, and then grab the woman and the kid." Michael said there was one firearm in the vehicle and that it was a "22 revolver." Michael said Benjamin grabbed the

"revolver". Michael said "one guy ended up dead, one of the aggressors end up dead." Michael stated, "when the two shots go off, the two people let go of me." Michael said when they let go of him that he grabbed the door and shut it. Michael said the guy that got shot, fell down, and the others that had a hold of Benjamin had let go "because they were next."

Michael said Benjamin was going to sit there and wait on the Police. Michael said that was not a good idea and that he assumed they would have guns that were easily accessible. Michael said he seen several guys running towards some vehicles and he believed they were going to get guns. Michael said he told Benjamin to leave. Michael said they drove off and once they got down the road a ways, they could see headlights behind them. Michael said they were trying to get to a Police station. Michael said they were over 100 MPH and the pursuing vehicles were able to catch up to them. Michael said each of the pursuing vehicles took turns on ramming them. Michael said the final ram is what sent them off the road and that he blacked out during the first roll.

I recapped with Michael to clarify some things. Michael said they weren't going that fast when they approached the party. I asked how close to the road they were and Michael stated, "some of them were in the road." Michael stated, "the thing is, if your drunk, and your in the road, we could go by going 15 MPH and they think were going too fast." I asked how far down the road they went once they heard the sound of something being ran over or something hit them, and Michael said they stopped immediately. Michael said he knew Benjamin seen them in the road, and that he wouldn't go by someone in the road that fast. I asked if they backed up or anything and Michael said he couldn't remember if they did or not.

I told Michael that I still had his phone and that he had previously given me permission to look at the video clip. I asked Michael if he would give written consent for me to access the phone and he said that he would. I handed Michael a written statement form for him to write out his written statement. I asked Michael his identifying information that is listed at the top of the voluntary statement form and filled it in for him.

Michael's wife showed me photographs of his x-rays and some of his medical records. She provided me with a disc that contained some of this information and she also emailed me some of the documents. I did not have a consent to search form with me, so I wrote out a statement and read it to Michael. Michael printed his name, signed, and dated under the statement.

On 05/09/2020 I, Deputy Svoboda Of the Kingfisher County Sheriff's Office, was off duty when I got notified of a shots fired call that was dispatched out.

At or about 2245 I went on Duty and was told to go to Bass Hospital in Enid where some of the victims were taken. I arrived at the Hospital where Deputy W. Thomas updated me on what he knew that occurred.

We were then informed from medical personal at the hospital that Christopher Robinson had passed away, who was the individual that got shot. I advised everyone at the scenes that he had passed away in case it affected what they were working on. Medical personal then notified Sierra Robinson, Christopher's wife.

We let Sierra have some time then informed her we needed to talk to her about the incident that had occurred. She agreed to talk to us and write out a statement. The interview was recorded with my body cam with her father beside her.

I asked her if she was at the incident when it occurred and she said yes. I asked her to tell us what lead up to it and to start at the very beginning. She said she arrived at Trevor Gritz house and every one was standing around the fire. She said it was just her and her daughter at the time and Chris was already there. She said they said hi to everyone and had been there 10-15 minuets when a truck went by at a high rate of speed. she said the truck was throwing rocks and there were a lot of kids out in the yard. She said everyone was saying slow down. She then says that he got a few ways down the road and then he braked and started backing up. She then said Chris sat his daughter down and a few of the guys obviously started walking over there. She called for her daughter and she said she did not see anything other than that. She said she started telling kids to get in the house. She then started walking in that direction yelling at Chris to come here. She said you could hear them saying you need to slow down and you don't need to be driving that fast. She then heard a "Pop Pop" and then she walked over there and Chris was laying on the ground. She said the guy was standing there in front of the door. She said you just shot my husband and with the gun still in his hand he said sorry. She then she ripped open Chris's shirt and saw two bullet holes. She then said two other women told her to get back because they knew CPR. She then heard someone say whats going on with someone else in the back seat because the door had opened up. She then told the other people they have a gun and told people to get back and then the truck sped off.

I then asked her if she knew anything that happened after they took off? She said no and she said tried calling 911 but no one answered. She said she was standing over Chris trying to figure out if he was alive. She then called her parents to come back because Chris had been shot. She then said somebody else had gotten in a vehicle and that two vehicles had left. She said she did not know but assumed they took off after the vehicle but she did not know.

Deputy W. Thomas then asked her why she thought the truck stopped? If it was because someone yelled at them? She said they stopped on their own but shes assuming because she does not know why they stopped. She said she did not hear anything besides them telling the truck to slow down. She then said he was a good ways up the road and then stopped and started coming back.

I then asked her if anyone threw anything at the vehicle when it was passing and she said no because it was going way too fast. She then drew a small picture of the area. She then says when he drives by he gets to where these vehicles are, pointing to the north side of the residence, he stops. I then asked to clarify is he was going North when he drove by and she said yes. She then points to the spot again and says He got to about right here then stopped and started backing up. I asked how fare off the road way the fire was that people were around and she said she did not know.

Deputy W. Thomas then asked if she could describe the vehicle and she said it was a truck but that was it. He asked her if there was anything else and she said the guy had a scruffy face. She then said that when the guy was sitting in the truck he had the gun in his hand in his lap and that it was a black gun. I asked her what kind of gun and she did not know besides it was a hand gun. She then pointed to her picture again showing us where he stopped and backed up at.

Deputy W. Thomas then asked her if she could describe the guy. She said that he was skinny and was white. She then said she could not see anyone else in the vehicle.

I asked her how many gun shots she heard and she said two. I then asked her when she ran up there after the gun shots if the man was in the truck or out of the truck and she said he was in the truck. She said that he was in his

truck. I then asked when she heard the gun shots if he was in his truck or out of it and she said she did not know and that she did not see. I then asked her if she heard him or anyone else say his name and she said no.

Deputy W. Thomas then asked her if he gave an explanation for what happened and she said no. She said that the only thing he said was sorry. I asked her if the vehicles that left the house were chasing him and she said she did not know she did not know if they were going to get help or what. I asked her if she knew who all were in the vehicles that left and she said no. I then asked her who all went up to the vehicle when it happened and she said she did not remember she just remembered Chris being one of them.

I asked her if she felt comfortable writing out a statement and she said yes.

While Sierra wrote out her statement we went into another room in the hospital to talk to James Jones who was at the incident when it occurred. James had also been writing out a written statement and gave that to us when we sat down.

I asked him if he was at the scene and he said correct. I then asked him if that was Trevor Gritz house and he said yes. He then gave the same directions to the house as Sierra did. I then asked him to go from the beginning to the end of what happened. James said that they decided to have a fire closer to the road. He said that a truck come by and it didn't help that it happen to be the third or fourth vehicle that came by fast. He said they could hear it from a while away and said they were coming. He said every time that someone would come by they would holler at them to slow down. He said he did not know if something got thrown at the truck. He said they were all right there about 20 feet from the roadway when the truck came by at like 70 mile an hour. He said the truck did not stop till they hit the neighbors house approximately 300 yards down the road. He said it then stop for what seemed like a minuet but probably 10-15 seconds. He then saw the reverse lights come on and they started coming back. He said then they started getting rowdy. I asked what he meant by rowdy and he said heading towards the road to meet this truck. I then asked him if it was a group of people and he said yes. I asked who all was in the group and he paused then said Trevor, Chris. Then said he cant really even call it a group because there was women and everyone headed down there. He then said they were at one driveway by the fire and the truck stopped at the other driveway which was about 40 yards apart. He said everyone was headed that way. He said him and some others then started gathering the kids up. He then said the door came open on the truck and two shots. I asked him if anything was said before the shots then asked him if he was up there when the shots were fired or a way back? He said he was 10 yards from it. He said he was actually getting onto his kid because he was trying to go out there. He then said he never even heard the gun shots and that surprised him. I asked him if there was any words exchanged and he said just "slow down motherfucker" and things like that. He then said after that he heard the screaming and people saying call 911. HE then said they waited there after they shot and he started talking. He then heard people in the vehicle start talking about self defense. He then said he did not know what happened because there was a bunch of people around the truck. He said he heard him talking about self defense and how it wouldn't of happened if you guys wouldn't of done this or that. He said he wasn't positive because he was focused on Chris. He said it started escalating and they took off. He then said him and some other started CPR on Chris. I asked him if anyone left the scene after the truck left and he said yes. I asked him if he knew who left and he said he didn't know exactly but several trucks left. He said there was no doubt they left to try and find him because no one got the full tag number. He said the vehicle had already gone out of sight before they left. I then said they took off looking for the vehicle and he said yes then said they took off in the same direction. I then asked him to describe the vehicle and he said dark truck with four doors and a john boat in the back. I asked him if he could make out a make or model on it but he was not sure but he thought it was a Chevy. He said the john boat was in the bed of the truck sticking 6-7 foot out the bed. He then said someone said the john boat was in the median in Bison. He then said if it was their vehicle that wrecked then they must of went to Bison if the boats there then came back. He said Mike told him the boats in bison and i asked who Mike was and he said Chris's brother. He said Mike was not there that he was headed out there. He said he was on his way to pick up their mother in Bison.

Deputy W. Thomas then asked if he was able to name everyone who walked to the truck and he said he could name everyone at the party. We then asked if the group of people outside were there and he said no. He said it was her husband and that he was the one that wasn't drinking. He said he shouldn't say that because everybody else there besides being a 3 yr old's birthday it was also a barbecue.

I asked him if he could tell us who all was there and he said yes. He then gave us a list of names who was at the party.

I asked him if there was anything else he could think of and he said they were trying to get their license plate as they drove off but he didn't think anyone got it and that is why he thinks someone of the guys took off to get the number. I asked him if he saw the gun and he said no. I asked him if the shots were loud and he said that he didn't hear them. He said from the looks of it, it looked like a pistol. Then showed us where he saw the wounds. He said he didn't know if he was shot twice but he saw one hole and the other arm bloody and that other people were saying he was shot twice. I asked him if he knew if anyone threw something at the vehicle when it passed and he said he did not know. He then said he wouldn't put it past anybody but he did not know. He then said it was about the fourth person to drive by too fast and by then everyone was getting more and more tired of people driving to fast. He then said that when they stopped down there it would of been long enough for them to make sure they were locked and loaded. He said then it happened and Sierra said you shot my husband and we have two daughters and then they started yelling self defense.

We then waited for Bobby Millis to get back from having tests done. Once she was back in her room we entered the room and I told her who I was and read her Miranda Rights. Bobby said she did not remember much and said she should probably have an attorney since she couldn't remember. We both exited the room then and I called SGT Davis to advise him. He told me that they were not looking at any charges for Bobby and she was not a suspect in anything and to inform that to her and talk to her again since she was not a suspect.

I went back in the room and informed Bobby that she was not a suspect and was not going to have any charges on her and I just needed to get her side of the story. I talked to her at length trying to jog her memory to see if she could remember what happened. She had visible injuries on her head and after a while it became apparent she could not remember what occurred. The last thing she remembered is going fishing earlier in the day then waking up in the hospital. I asked her if he husband carried a gun to the lake or anything and she did not know. As we exited the room I told her if she started to remember anything to get our attention.

Myself and Deputy W. Thomas then waited for the medical examiner to arrive at the hospital. Once at the hospital we entered the room where Christopher Robinson's Body was. I took photographs of Christopher and his injuries. I observed what appeared to be a bullet wound in his right upper chest area with burn marks around it. I then observed what appeared to be another bullet wound on the underside of his right forearm with burn marks around it. I also observed what appeared to be more bullet wounds on his left upper for arm and shoulder with burn marks around them. I then collected Christopher's clothing as evidence and secured them in the back of my patrol unit. We then left the hospital.

While back en route we came to the wreck scene where Deputy Redlinger was at the scene. He informed us he was looking for truck parts that could be from the one that caused the wreck. We then helped him search in the roadway and ditches. Trooper Wiemer then arrived on the scene and we found what appeared to be head light/brake light pieces in the road way and ditch. I collected them as evidence for the Trooper then gave them to him. We then left the wreck scene and went to the shooting scene where I updated SGT Davis of everything.

Once back at the Office I transported the evidence I secured in my unit to the Evidence locker securing it there.

On 05/11/2020 I contacted Lindsey Jones who was a witness to the event. I met her at her residence to write out a statement and talk about what happened. I asked her to tell me what happened from start to finish. She said she went there with her 5 year old for a birthday party. She said her husband and 10 year old later came where the kids all played. She said when the sun went down they started a fire and everyone was there hanging out. She said she was on the West side of the fire facing house. She said they heard the pick up come off the black top on to the gravel. She said honestly in his defense he was about the third pickup that had driven by about 60-70 mile an hour. She said the kids were playing in the bar ditch right next to the road in the mud. She said they were super close to the road to. She said she turned and said the truck looked black and had a john boat sticking out of it. She said everyone was yelling at it to slow down with profanity. She said she did not know anyone threw anything until someone had told her they did yesterday. She said the vehicle did not brake till Trevor's North drive way. She said he never hit the breaks till then. She then said the truck sat down there for a good 30-40 seconds then started backing up. She then said Chris, Trevor, Jared, Chad, and Lane Greene all started walking towards the road and past the trees. She said she did not know if anyone else walked up there or not because she stayed behind with her husband and the kids. She said she did not think a lot about it because she did not know if they knew him or anything. She said she did not hear a lot of screaming or yelling but she did see the door open on the drivers side. I asked her if the driver door opened and she said yes the driver door opened. I asked her if she saw who opened the door and she said she did not see who opened it. She did not know how the door opened but did see it open. Her and her husband then started taking kids

inside the house. She then heard the gun shots and said she heard two shots that sounded like air soft gun shots. She said she yelled out that is gun shots to her husband and to get her purse where her gun is in case they got out the vehicle and came in. She said no one on their side was armed or anything. She said she never took her weapon out and they stayed in the front yard and the truck stayed there. She did see a body fall and they never went out there. She said the truck stayed for 45 seconds to a minuet. Once the truck left they ran out there and she ripped Chris's shirt off and started CPR because he did not have a pulse. I asked her if she saw anyone take off after the truck and she said yes. Chad and Jared took of in trucks after them. She said their last names were Dowell. I asked her what direction they took off after them and she said she did not know. I then asked her if she would write out a statement which she did and I picked up later.

At approximately 9:37pm on 05/09/2020, I received a call via text on my phone of a gunshot victim north of SH51 on Cemetery Road in Hennessey, Oklahoma within Kingfisher County jurisdiction. I was in my unit and headed towards Hennessey, Oklahoma at 9:44pm. While enroute to this call, I was contacted by Sgt. Todd Davis via cellphone and briefed on what he had been told about this call. The radio traffic was extremely busy and as far as I knew, we were responding to the shots fired call only, and Air Evac was already enroute to the scene. I asked what Kingfisher County Deputy was at the scene. I was told by dispatch, it was Deputies Nick Countryman, Sterling Snow, and Wayland Thomas. As I was enroute north on US 81, I found out we had two scenes these deputies were on and possibly related. I was told there were two, Air Evac helicopters and they were on scene. I was able to get ahold of Deputy Nick Countryman who was on the accident scene along with deputies Snow and Thomas. I told Nick to go wherever the helicopter flew this accident victim, which ended up being OU Trauma in Oklahoma City, Oklahoma. I was told the second helicopter refused transport on the shooting victim because CPR was underway on him. I was told he was being taken to Bass Integris in Enid, Oklahoma and I had Deputy Wayland Thomas go with that victim. I responded to the shooting scene on north Cemetery Road along with Deputy Jonathon Redlinger. When we arrived on scene, the ambulance had already left with the shooting victim when I received a call from dispatch to continue farther north on a report of a male wearing coveralls walking in the ditch that could be related to this shooting call. At this time, Deputy Chuck Countryman had arrived on scene and I had Deputy Redlinger begin the shooting investigation at the scene while deputy Chuck Countryman and myself went north in an attempt to locate this individual walking in the ditch. We drove north on Cemetery Road to countyline road 590, I drove east to US81 while Deputy Countryman went another mile north, into Garfield County. We did not locate any individual walking. We were enroute back to the shooting scene when we passed a damaged white Ford pickup sitting with its lights off approximately 1 mile north of the shooting scene on the west side of the road in an oilfield lease. I observed front end damage but no one around this vehicle. Deputy Countryman felt the motor, and it was still warm to the touch. I contacted Sgt. Todd Davis and told him what I had and I would be securing this as a possibility of it being related to the shooting.

I stayed on scene with this vehicle while Deputy Countryman went to the scene of this shooting and began to assist Deputy Redlinger with the investigation. After being on scene for approximately 20-30 minutes, Lt. John Weimer and Trooper Mark Williams of the Oklahoma Highway Patrol arrived at my location. I was told by Lt. Weimer that we had 4 scenes working, all possibly related to the shooting. I was told we initially had the shooting and the suspect vehicle left northbound being pursued by another vehicle. The vehicles went east to US81 Highway and then north to Bison, Oklahoma where the suspect vehicle was hit from the back. The suspect vehicle turned around and was southbound on US81 Highway towards Hennessey, Oklahoma where it was forced off the road causing this accident. I stayed with the vehicle along with Trooper Mark Williams for further investigation by Sgt. Todd Davis or until released to the Oklahoma Highway Patrol.

After releasing this vehicle to the Oklahoma Highway Patrol, I went to the shooting scene and assisted Sgt. Davis and Ken Thompson on obtaining any statements, taking and securing evidence, and assisted in any further investigation. After obtaining statements and talking to individuals that witnessed what had happened, we left the scene at approximately 6:00am on 05-10-2020.

Deputy W.Thomas advised me to go ahead and have dispatch get a mediflight helicopter on the way as well.

I went back to my patrol vehicle and advised dispatch of what was needed. I then called my Supervisor, Sgt. Michael Shults to advise him of what was going on. Sgt. Shults advised he was aware and was on his way. Sgt. Shults told me to follow the helicopter to whatever hospital they were taking the victim to so we could get his information.

After the mediflight helicopter left the crash site I followed it to OU Trama Center in Oklahoma City. Once I arrived I went into the ER and spoke with a nurse who advised me the victim was rushed into the operating room to get the bleeding under control. I was able to obtain all his pertinent information from the ER staff. I then left the hospital with the victims information. The victim is now known to me as Michael Andrew Porter.

When I arrived back into Kingfisher County I met with Sgt. Todd Davis and gave him Porter's information.

I noticed a green in color 2004 Chevy Silverado bearing an Oklahoma tag of BMA 689 on the northwest of the crime scene with appeared to have gray in color paint exchanged on the lower passenger side door and damage to the bumper also on the passenger side.

I relayed the information to Sgt. Davis. A short time later, Southside Wrecker Service arrived to the crime scene and took possession of the vehicle.

Deputy C. Countryman collected all the physical evidence. I was released from the crime scene by Sgt. Davis.

On Saturday night, May 09, 2020 at approximately 21:30 hours, Deputies of the Kingfisher County Sheriff's Office were dispatched to 2484 N. 2860 road in Kingfisher County, Oklahoma in reference to someone being shot. Shortly after, Deputies were also dispatched to a roll-over wreck on Highway 81, north of Hennessey, Oklahoma which is located in Kingfisher County.

While on my way to the scene I, Deputy Charles Snyder was advised by dispatch that the RP on the phone was a female who was involved in a crash. The RP stated to dispatch that there was still people in the car and they were trapped and could not get out. The RP also stated that they were in the middle of a field somewhere just off of highway 81, and she was standing there waving her cell phone waiting for help.

When we located the crash site, I rushed out to the vehicle. Deputies, W. Thomas, C. Snow and Nicholas Countryman also arrived at this time and we all went to the crashed vehicle to assist in trying to get the other individuals out of the truck. Deputy W. Thomas is also a paramedic, he advised that we needed to make sure that fire and EMS were on their way just in case we could not free the other occupants from the truck. At this time Deputy W. Thomas advised that the back seat passenger had a severe head injury and that he was losing a lot of blood. Deputy W. Thomas advised to go ahead and have dispatch get mediflight helicopter on the way.

Deputy Thomas and I climbed in to the vehicle to assist the person that was in the back seat of the truck. The person was awake and alert. He also had a portion of his right face missing do to a motor boat engine that was in the back seat laying on the floor in between the front seat and back seat of the vehicle. Deputy Snow busted out the front windshield. Deputy Thomas and I took the injured person out the front window do to the fact that the rest of the vehicle was damaged. We placed the injured person in the field in the recovery position and waited for mediflight to land.

While getting to the injured person out of the vehicle, the driver of the vehicle was applying pressure to the injured person face. I asked the driver which one of you has the gun and how did the shooting. The driver stated that he shoot the gun and it was a 22 Cal. and its in the vehicle some where. I stated to him when you get out of the vehicle, I need you to walk over to Deputy Countryman and he is going to place hand cuffs on your wrist. You are not under arrest just being detained until we can get your friend out of the vehicle. The driver climbed out of the vehicle and walked over to Deputy Countryman. Deputy Countryman placed him in a patrol vehicle until Deputy Davis arrived.

At approximately 21:30 hours on 05-09-2020, I was dispatched to 2484 N. 2860 road in Kingfisher County, Oklahoma in reference to someone being shot. Shortly after another call came out of a roll-over accident on Highway 81, north of Hennessey, Oklahoma which is located in Kingfisher County.

While on my way to the scene, I was told by dispatch, the reporting party on the phone was a female who was involved in this crash. This female told dispatch there was still people in the car and were trapped, unable to get out. This female also said they were in the middle of a field somewhere just off of highway 81, and she was waving her cell phone for help.

When we located this accident, Kingfisher County Deputies, Waylon Thomas, Charles Snyder, Nicholas Countryman and myself went to the crashed vehicle to assist in trying to get the other individuals out of the truck. Deputy Waylon Thomas, also a Nationally Certified Paramedic, said we needed to make sure that fire and EMS were on their way just in case we could not free the other occupants from the truck. At this time Deputy Waylon Thomas said the back seat passenger had a severe head injury and that he was losing a lot of blood. Deputy Waylon Thomas told us to go ahead and have dispatch get a AirEvac in the air and enroute.

Deputies Thomas and Snyder climbed in to the vehicle to assist the person that was in the back seat of the truck. The person was awake and alert. He also had a portion of his right face missing do to a motor boat engine that was in the back seat laying on the floor in between the front seat and back seat of the vehicle. I busted out the front windshield. Deputy Thomas and Deputy Snyder took the injured person out the front window do to the fact that the rest of the vehicle was damaged. Deputy Thomas and Deputy Snyder placed the injured person in the field in the recovery position and waited for AirEvac to land. While waiting for the helicopter, Deputy Thomas Advised me to cut his clothing off so he could be further evaluated by the medical personnel. After that I placed crime scene tape around the accident site.

On Saturday night, May 09, 2020 at approximately 21:30 hours, Deputies of the kingfisher County Sheriff's Office were dispatched to 2484 N. 2860 road in Kingfisher County, Oklahoma in reference to someone being shot. Shortly after, Deputies were also dispatched to a roll-over wreck on Highway 81, north of Hennessey, Oklahoma which is located in Kingfisher County.

While on my way to the scene I, Deputy Wayland was advised by dispatch that the RP on the phone was a female who was involved in a crash. The RP stated to dispatch that there was still people in the car and they were trapped and could not get out. The RP also stated that they were in the middle of a field somewhere just off of highway 81, and she was standing there waving her cell phone waiting for help.

When we located the crash site, I rushed out to the vehicle. Deputies, C Snyder, C. Snow and Nicholas Countryman also arrived at this time and we all went to the crashed car to assist in trying to get the other individuals out of the truck. Deputy W.Thomas is also a paramedic, he advised that we needed to make sure that fire and EMS were on their way just in case we could not free the other occupants from the truck. At this time Deputy W.Thomas advised that the back seat passenger had a severe head injury and that he was losing a lot of blood. Deputy W.Thomas advised to go ahead and have dispatch get mediflight helicopter on the way.

Deputy Snyder and I extricated a 4 y/o female from the passenger window by manually lifting the 4 y/o female and passing her to Deputy Snow, i then assessed the last occupant noting he had massive maxofacial trauma and was hemorrhaging massive amounts of blood. Deputy snyder passed my medic bag to me and i manually placed the right side of the pt's face back in in anatomical posistion along with trauma gauze and combat gauze upon the bleeding. along with a oliase bandage and direct pressure. the pt was a&o x 2 and was unable to talk and tell me what had happen. Deputy Snow sledge hammered the windshield out. i then manually dragged the pt out of the front windshield placing him in the recovery position. while i did a further detailed trauma assesment. airevac was making there approach and landing. upon the flight crew walking up i gave pt report and handed pt care off to them. I then accompanied Deputy Svoda to Bass Integeris to assist in the initial interviews. of the peoples involved in the incident that where present at the hospital e.r.

On May 9, 2020 at approximately 11:45 hours, I received a call from Sgt. Todd Davis with the Kingfisher County Sheriff's Office. Sgt. Davis stated deputies had been dispatched to a shooting west of Hennessey. He also advised there were two crash scenes in addition to the shooting scene. On May 9, 2020 at approximately 11:45 hours, I received a call from Sgt. Todd Davis with the Kingfisher County Sheriff's Office. Sgt. Davis stated deputies had been dispatched to a shooting west of Hennessey. He also advised there were two crash scenes in addition to the shooting scene.

I contacted Sgt. Davis while travelling north between Kingfisher and Hennessey to determine where he wanted me to respond. He advised he was located on the rollover crash scene on the west side of US Highway 81 just north of Hennessey and for me to meet him there.

Upon arriving at the crash scene, I observed a dark colored pickup lying on the driver side in a wheat field on the north side of the location. As I walked closer, I could see the vehicle had sustained severe body damage indicative of a rollover crash. While speaking with deputies on the scene, they told me the shooting scene was just west of our location and another crash scene was located north of our location in Bison. Deputies also said that Kingfisher County Deputies were at the shooting scene and Oklahoma Highway Patrol Troopers as well as Kingfisher County Deputies were located at the scene in Bison. Deputies on the scene also advised that due to CPR being performed on the subject that was shot, he had to be transported by ground to the hospital in Enid. They advised that the female passenger and the four (4) year-old passenger in the rollover vehicle had been transported by ground to the hospital in Enid. Deputies also stated the driver was in Sgt. Davis' vehicle and the other back-seat passenger had been transported to the OU Medical Center by Medi Flight.

As I approached Sgt Davis's vehicle, he rolled his driver's side window down. When I arrived at the window, Sgt. Davis was interviewing the driver of the rollover vehicle, later identified to me as Benjamin Allen Millis. I stood at the window of the vehicle where I could hear the interview. Sgt. Davis informed me of the conversation with Benjamin prior to my arrival as Benjamin listened and verified. Sgt. Davis then continued his interview with Benjamin.

Sgt. Davis received a phone call and stepped out of his vehicle and I sat down in the vehicle and continued the interview in Sgt. Davis' absence. We discussed details leading up to this crash scene such as: roads taken, direction of travel, speeds, description of vehicles that pursued him, the firearm he had in the truck, his thought process throughout this ordeal, and his family's welfare. All of my and Benjamin's conversation was captured on Sgt. Davis' recording device, as reflected in Sgt. Davis' report.

The ambulance arrived on scene to evaluate Benjamin's medical condition. At that time, medical personnel escorted Benjamin to the ambulance for evaluation and I joined Sgt. Davis. We examined the crashed vehicle. I observed Sgt. Davis photograph the vehicle and its contents. We discovered the firearm we believed was used in the shooting along with a second magazine. The firearm was the same make and model of the firearm that Benjamin mentioned to me during our conversation in Sgt. Davis' vehicle. I observed the evidence being collected and placed in an evidence bag.

I left the crash scene and followed Sgt. Davis to where the shooting occurred, identified as 2484 N. 2860 Road in Kingfisher County. We approached the location from the north and upon arriving at the scene I observed several subjects walking around or sitting by a fire located in the front yard of the residence approximately 30 feet off the roadway.

While examining the scene for tire marks on the roadway, Sgt. Davis approached me and requested I examine the damage of a blue early 2000's model Chevrolet pickup belonging to Levi Copeland. The truck was located in the north driveway of the residence and Sgt. Davis advised Trevor Gritz, the owner of the residence, had given us consent to be on the property to look around.

I examined the damage to the blue Chevrolet pickup and determined it was consistent with damage caused by the vehicle making contact with another object (possibly a vehicle) while it was moving. I disclosed to Sgt. Davis, Benjamin had described one of the pursuing vehicles as a late 90's or early 2000's model Chevrolet. We decided the vehicle needed to be searched for further investigation. Levi gave us consent to take the vehicle and he was allowed to retrieve any items he needed from inside the vehicle. A short time later, Southside Wrecker Service arrived and took possession of the vehicle.

At this time, I spoke with the driver of the wrecker about where the rollover vehicle was placed at his location. He stated it was either under an awning or inside a bay. I requested it be tarped off if it was located outside under the

awning due in coming storms. He assured me he would take care of it.

It was later determined that the damage on Levi's vehicle was present prior to the night of the incident. However, I would not rule out Levi's vehicle as one of the vehicles that pursued Benjamin Millis' vehicle at some point that night due to the Benjamin's description of one of the pursuing vehicles.

After interviews had been completed and evidence collected, we released the scene. At this point, we knew the F-150 driven by Jarod Dowell had been involved in the crash in Bison and is now secure in our custody. Also, we knew that Chad Dowell's F-250 was involved in the crash at the rollover scene and at this time we are unaware of its location. Sgt Davis and I knew our next step was to locate Chad Dowell's Ford F-250 pickup. We decided to return to the rollover scene and search for evidence that would indicate the direction of travel after the collision.

After arriving at the scene and examining the roadway, we discovered fluid leakage at the point of impact that we believed to be transmission fluid from the transmission cooler located at the front of the F-250 pickup. We followed the trail of fluid South on US Highway 81 to CR610. On the shoulder of the northwest corner of this intersection we located a pool of fluid with a chrome plastic piece of grill. We continued to follow the fluid trail to the west on CR610 and the drips lessened as we continued until we were no longer able to locate the trail. It was now daylight and Sgt. Davis and I decided to drive the roads in an attempt to locate the vehicle on the side of the road or in a field off the roadway. After several minutes of searching, we determined it was pointless to continue. We decided to go to Chad and Samantha Dowell's residence, located on CR 2880 and attempt to make contact with Chad.

Upon arriving at the residence, Sgt. Davis rang the doorbell and Samantha came to the door. Sgt. Davis asked if Chad was home and Samantha responded yes and went back inside the house to get him. Chad and Samantha came out on the porch of the residence. Chad was extremely evasive and vague when answering Sgt Davis' questions and refused to reveal the location of his F-250 pickup. Sgt. Davis started walking away from the porch and I informed Chad, if necessary, we would obtain a search warrant for the location of the truck and Chad replied, "Whatever" and walked back inside the residence. Samantha said she would go in and talk with him and returned inside the residence.

Sgt. Davis and I walked back to his vehicle and were discussing our options when Samantha exited the residence and walked to our location. Samantha said she didn't know why Chad had to be like he was being. Samantha said the vehicle was approximately four miles to the west. She said she would be right back and went back into the residence.

A short time later, Samantha exited the residence in different attire and carrying her purse. She asked if we wanted to follow her. We followed her to the pickup located at a residence just south of the intersection of CR2830 and CR590 in Kingfisher County. Upon arriving at the residence, we drove east on a dirt drive located south of the house. We drove down into a low spot of the drive and observed the Black Ford F-250 parked between a wheat field and some trees. The location of the F-250 indicated it was parked there for concealment purposes. The Black Platinum F-250, Oklahoma license plate IDF479, had obtained significant damage to the front of the truck consistent with a high impact crash.

Sgt. Davis thanked Samantha for showing us where the truck was located. Samantha asked if they needed to leave the truck here or if they could take it home now that we had seen it. I explained to Samantha they could take the vehicle to their residence; however no changes could be made to the vehicle. Samantha stated she kept playing the shooting incident over and over in her head searching for the details of how it transpired. I explained to Samantha that I believed Chad was downplaying their (guys at the party) role in the incident. I explained to Samantha, while talking with her and Chad earlier, Chad said they walked to the truck and at the same time she had said rushed out there. Samantha replied, "They did." Samantha said when they went back into their house, she asked him why he didn't tell us she was the one that brought him home. Samantha said Chad told her he didn't want to get her in trouble. I asked Samantha if she knew how many trucks left the house to give chase. Samantha said there were two, Chad and his brother.

While photographing the truck Sgt. Davis asked Samantha if she knew who pulled the truck to this location and Samantha said she did. She said Chad called her and said he crashed his truck and wanted her to tow it. She said Chad told her where to pull the truck. We departed the location of truck and drove back to the Kingfisher County Sheriff's Office. We decided the truck should be secured to avoid any tampering with the vehicle. Sgt. Davis contacted Lt. Weimer with the Oklahoma Highway Patrol and informed him we had located the Black F-250 with front end damage. Sgt. Davis stated Lt. Weimer wanted to obtain a search warrant to secure the vehicle and requested someone to secure the pickup until that process could be completed. Sgt. Davis said he was going back to the location

of the truck until Lt. Weimer could secure it.

On May 12, 2020 at approximately 1445 hours, Lane Green and Mallory Craig came to the Kingfisher County Sheriff's Office to interview with Sgt. Davis. I sat in on both interviews and the details of the interviews are located inside Sgt. Davis' report.

On May 13, 2020, Sgt. Davis obtained a search warrant for Benjamin Millis' Toyota Tundra. A request in the search warrant was to have Southside Wrecker Service move the vehicle to the Kingfisher County Sheriff's garage. Sgt. Davis contacted Southside Wrecker Service and requested they move the vehicle to the Sheriff's Office garage. We then drove to the garage to allow them to place the vehicle inside.

Sgt. Davis contacted the Kingfisher Fire Department and asked if they could come to the garage and use their equipment to remove the top of the collapsed cab on the vehicle. Once the top of the vehicle was removed and the Kingfisher Fire Department departed, we executed the search on the inside of the Tundra. During the search, several items not pertinent to the investigation were removed and placed on large plastic sheets in the garage. Also, during the search two iPhones were photographed, collected, and placed in evidence bags. In excess of 400 rounds of .22 caliber ammunition and four .22 caliber magazines were collected and bagged. Due to the transfer of items inside the truck during the rollover we removed parts of the dash, seats, and carpet to gain access where items could come to rest. In order to obtain an endoscope camera for additional search, we temporarily stopped the search and secured the facility at approximately 2300 hours.

On May 14, 2020 at approximately 1321 hours, Sgt. Davis and I arrived at the garage and resumed the search of the vehicle. We used the endoscope camera to search inside the doors, small holes inside the vehicle, and in and around the dash of the vehicle. We limited our search of the dash in order not to disturb the GPS and air bag modules. Trooper Ledbetter of the Oklahoma Highway Patrol was in the process of obtaining a search warrant for these items. We secured and departed from the garage at approximately 1500 hours.

On May 19, 2020 at approximately 1354 hours, Sgt. Davis and I met Trooper Ledbetter with the Oklahoma Highway Patrol at the Sheriff's Office garage to execute his search warrant on Benjamin's Toyota Tundra. Trooper Ledbetter collected the GPS module from the dash of the vehicle and the air bag module from the center floorboard underneath the dash of the vehicle. After Trooper Ledbetter departed, Sgt Davis and I performed an additional search of the inside of the dash and vehicle for possible .22 caliber shell casings. A short time later we concluded the search and secured the garage.

On the evening of May 27, 2020, Sgt. Davis and I, along with other Kingfisher County Deputies, entered the Kingfisher County Sheriff's Garage and loaded the non-pertinent items that were removed from the Tundra back into the vehicle in order to have the vehicle taken back to Southside wrecker Service. Nothing further to report Deputy Ken Thompson

On Saturday May 9th, 2020 at approximately 21:30 hours, I, Jonathan Riedlinger, Deputy with the Kingfisher County Sheriff's Department, Kingfisher County, OK. was informed of a shooting that had taken place in the county NW of Hennessey, OK. The directions given were 1 mile West of U.S. Hwy 81 & State Hwy 51 and 1.5 miles North on Cemetery Road. This location is located within the county limits of Kingfisher County. I made contact with Deputy Sgt. Mike Shults and asked if he needed more deputies, as the shooter was unknown and direction of travel was unknown as well. Sgt. Shults stated, the information is limited at this time, but is confirmed that one individual has been shot. I let Sgt. Shults know that I will head that way and provide any assistance needed. I let dispatch know that I was 10-8 enroute to this location. Once enroute, I heard on the radio about a traffic accident that had taken place as well, approximately two to three miles North of State Hwy 51 on U.S. 81. I radioed Sgt. Shults and asked where he wanted me to proceed to and he replied to the scene of the shooting. Once I arrived at the shooting location, NW of Hennessey, OK., I recognized this residence to belong to Trevor Gritz. I let dispatch know I had arrived on scene and parked my patrol car on the county road, just South of the South driveway entrance to Trevor's residence, due to observing wood debris leading from the South driveway and trailing in the Northwest direction. It appeared that this debris had fell out of the back of a vehicle or trailer. Once I got onto the property, I observed several individuals standing around a firepit in the front yard and a couple individuals near and in a Ford F-250 pick-up truck parked at the North entrance. I identified myself and who I was with and asked if Trevor was there. Someone went into the house to get Trevor. While waiting for Trevor to come out, I went to the Ford F-250, to ask the male and female individuals to come to the firepit as well. The female, (who was later identified as Stephanie Dowell), asked if she and her husband, (who was later identified as Jarod Dowell) could leave and take their kids home? I let her know that at this time, I needed them and everyone else to stay here, so I can gather some information about what to place for the investigating Deputy. Jarod, Stephanie, and their 5 year old and 11 year old children then followed me over to the firepit, where everyone else was, including Trevor. At this time, Deputy Chuck Countryman had arrived at my location and informed me that he had found a white truck about 3/4 miles North of our location. He said that it appears to have front end damage to it and still felt warm, however no one was in or around the vehicle. I asked if he would park his patrol vehicle on the county road, just North of the North entrance to Trevor's property. I then spoke with Trevor and everyone else standing around the firepit and explained that I needed to gather some information on what took place this evening, so I can pass it along to the investigating Deputy. I let them know that we would be there for a while, as he would have to come over and talk with each of them, but for know, I needed to get some basic information from them and also information about what happened. Trevor explained that they were all hanging out at his house today, since they had a birthday for one of his kids. As Trevor and I were talking, I could smell a strong odor of an alcoholic beverage emitting from his person. He said that everyone was hanging out, eating food, and the kids were all playing together. He and Jarod both stated that the kids had been playing in the ditch next to the road, since it had water and mud in it. I asked if anyone had been drinking earlier today or this evening. He stated yes. Trevor then explained that several people and their kids had left after the party was over and the evening started getting later. He said that a dark Grey or dark Brown colored Dodge pick-up truck had driven by multiple times and had been driving very fast. He and Jarod both stated that they became mad over this, since all the kids were in the ditch playing in the mud. Trevor stated that on the third time that the truck drove by, he threw the beer can that he had been drinking at the truck and hit it. He said that he thinks that he hit the drivers rear door or the driver's side bed of the truck, but did not know for sure. He said that he knows that he hit it for sure, because the truck then stopped a little further down the North of his property. I asked them if the truck had any distinguishing marks on it. He said that there was a "John Boat" in the bed of the pick-up. I then asked what happened next. He said that the truck then started to back up and then stop. Trevor said that he, Jarod, and Chris walked up to the truck so they could talk with the driver about driving so fast, so many times. He then stated that before they made it up to the truck, the driver stepped out of the truck and began to shoot at them. He said that the driver gets back into the truck and speeds off. I asked where this took place. Trevor walked me over to the area he thought it was, which was located just to the North of the North entrance to his property. I walked around and eventually observed and located some blood. One spot of blood was about the size of a quarter and another spot was smaller than a dime. I then asked what happened next. Trevor stated that they then helped Chris out, since he had been hit by the rounds. Trevor stated that he thought he heard two or three shots, but saw either three or four entrance wounds. Trevor stated that it was a .22 cal suppressed firearm. He believed that it was pistol, but could not tell for certain. I asked Trevor how far they were standing when the driver started to shoot at them. Trevor stated that he thought they were about 15-20 yards away. He then stated they called 911 for Deputies and EMS. I contacted Deputy Sgt. Todd Davis and filled him in with the information I had at the time since he was at the accident scene, just Northeast of our location. Deputy Countryman asked who's truck was parked about 3/4 of a mile North of here. Trevor stated that the truck was his and it was his work truck. I asked how it ended up there and with damage. Jarod stated that it was from him and that he was driving the truck, because he left to chase after the truck to get the information for Deputies. I then walked over to Jarod and asked him to explain what he did next and asked why it is parked down there and not at the house? He said that when he was chasing after them, at some point the shooter slammed on his breaks, causing Jarod to rear end

him. He said that he then had to limp the vehicle back. He said that where the truck is sitting, is as far as it made it before not being able to move on it own power. I asked if he walked back here. Jarod stated that he called his buddy Levi Copeland and he came to his location, picked him up, and took him back to Trevor's. I asked if he remembered the route they took and where the impact took place, so I can let Deputies know. He said that he can not remember the exact route, but said that they were up by Bison, OK. and the shooter's vehicle turned around and then slammed on his breaks and that when he hit. I asked since he had been able to chase the shooters vehicle, if he was able to get a better vehicle description. He said not really, but he did get the tag number. He stated that it was Oklahoma BLT 384. During my conversation with Jarod, I could smell a strong odor of and unknown alcoholic beverage emitting from his person. I then called Deputy Sgt. Davis again and let him know this information. Deputy Sgt. Davis, confirmed with me that the accident that they are on, is going to be the shooters vehicle. I continued to talk with Trevor, Jarod, and now Levi and asked what happened next. He said that they have been here ever since, until my arrival. I then asked if everyone here, were the only ones during the incident. They replied yes. I asked Trevor how the wood in the road got there and if something was hit. He stated that the wood was in the back of his work truck, backed up to the firepit and when Jarod took off, the wood fell out of the back of the truck, into the road. I asked Trevor, Jarod, and Levi how the accident took place Northeast of our location. They all said that they do not know anything about the accident. I let them all know to hang around until the investigating Deputy arrives, as he is about done at the accident scene and will be here shortly. They asked if they could go to the bathroom, get something to drink, and get blankets for the kids. I let them know that is okay, but not to drink any alcoholic beverages. They all laughed and said, I think the drinking is done for the night. Later on, Deputy Sgt. Shults, Oklahoma State Highway Patrol Trooper Seth Wallace and Trooper Lt. John Weimer were there. Deputy Sgt. Davis called me and asked if any vehicles had any front end damage to them, other than the white truck that belonged to Trevor. I told him I would look and see. I then walked up to the property and asked Trevor if the vehicles here are the ones that that have been here the whole time, minus his work truck, but adding in Levi's from picking up Jarod. Trevor stated yes. I then walked around the vehicles and noticed an early to mid 2000's Chevrolet 1500 that had damage to front passenger side from the bumper to the rear passengers door. I then called and notified Deputy Sgt. Davis. After awhile, Deputy Sgt. Davis and Deputy Ken Thompson arrived at our location. Deputy Sgt. Davis informed every officer there, that a possible Black Ford F-250, is the suspect vehicle, that rammed the shooters vehicle, causing it to depart the roadway and be involved in the major accident it was in. Deputy Sgt. Davis also stated that they recovered a suppressed .22 cal pistol from the shooters vehicle. Trooper Lt. Weimer stated that they had recovered the "John Boat" from the back of the shooters vehicle, at the turn about in Bison, OK. Deputy Sgt. Davis stated that he was going to start his interviews. I then spoke with Trooper Lt. Weimer and we decided to go to the crash scene and put some fresh eyes on the location. While there, we observed several pieces of what appeared to be broken tail/brake lamps and also observed several small pieces of chrome plastic, that appeared to be from a front grill of a vehicle. These were collected and placed into evidence back from Trooper Lt. Weimer. After this, I then returned to the scene of the shooting and asked if they needed anything else from me. Deputy Sgt. Davis stated no and released me from the scene.
